I have read the General Consent Form and understand that information provided by me for the purposes of the Onboarding Check will be forwarded to the Australian Criminal Intelligence Commission (ACIC), other Australian police agencies and other third parties for the purposes of checking this information.

By signing the General Consent Form, I am consenting to ACIC and other police agencies accessing their records in relation to me to obtain and disclose police history information that relates to me to the Department. I also consent to other third parties to whom the Department discloses my personal information for the purposes of the Onboarding Check to disclose my personal information to the Department.
- 7. I acknowledge that I understand that if I receive an adverse Onboarding Check, I will not be eligible to be employed by the Department or otherwise provided with non-public access to the Department's assets.
- 8. I certify that, to the best of my knowledge, all information I have provided and that I may provide in the future to support my Onboarding Check is true, accurate and complete.
- 9. I acknowledge that I understand that the Australian Government's Protective Security Policy Framework requires me to provide an assurance to the Department that I will comply with the Australian Government's policies, standards, protocols and guidelines that safeguard the Australian Government's people, information and assets from harm.
- 10. I agree to comply with all relevant departmental and Australian Government Protective Security policies and procedures, as amended from time to time.

I believe that the statements in this declaration are true in every particular, and I understand that a person who intentionally makes a false statement in a statutory declaration is guilty of an offence under section 11 of the *Statutory Declarations Act 1959*, the punishment for which is imprisonment for a term of 4 years.
