### **Decision**

I am an officer authorised under section 23(1) of the FOI Act to make decisions in relation to FOI requests.

My decision is to exempt in part the documents which fall within the scope of your request.

A statement of reasons for my decision is below.

You should read the documents in conjunction with the Schedule of Documents and the statement of reasons.

### Information considered

In reaching my decision I have considered the following:

- the Freedom of Information Act 1982;
- the FOI guidelines issued by the Australian Information Commissioner;
- departmental documents (identified above);
- consultation with the relevant business areas within the department; and
- consultation with the Australian Customs and Border Protection service.

### Reasons for decision

I have considered the documents within the scope of your request and applied deletions and exemptions in part to information as detailed in the Schedule of Documents. You should read the schedule in conjunction with the exemptions below.

### FREEDOM OF INFORMATION ACT 1982 (FOI Act)

### Section 22 Deletion of exempt matter or irrelevant material

- (1) This section applies if:
  - (a) an agency or Minister decides:
    - (i) to refuse to give access to an exempt document; or
    - (ii) that to give access to a document would disclose information that would reasonably be regarded as irrelevant to the request for access; and
  - (b) it is possible for the agency or Minister to prepare a copy (an edited copy) of the document, modified by deletions, ensuring that:
    - (i) access to the edited copy would be required to be given under section 11A (access to documents on request): and
    - (ii) the edited copy would not disclose any information that would reasonably be regarded as irrelevant to the request; and
  - (c) it is reasonably practicable for the agency or Minister to prepare the edited copy, having regard to:
    - (i) the nature and extent of the modification; and
    - (ii) the resources available to modify the document; and
  - (d) it is not apparent (from the request or from consultation with the applicant) that the applicant would decline access to the edited copy.

The information deleted under section 22(1) of the FOI Act is considered exempt or irrelevant to your request. While the FOI Act extends a legally enforceable right of any person to seek access to documents held by an agency, section 22(1) allows an authorised FOI officer to remove information that is exempt material or material that is reasonably regarded as irrelevant to the request.

On the 8 January 2014 you agreed that an individual's personal identifying information and staff details would be irrelevant to the scope of your request. This type of information has been deleted from the documents within the scope of your request, I have included some advice in the Schedule of Documents so that you can identify what type of material it is that I have applied s.22(1) to, these deletions are also clearly marked within the documents.

In accordance with section 22 I have prepared an edited copy of the documents for release.

### Section 47E Public interest conditional exemptions—certain operations of agencies

A document is conditionally exempt if its disclosure under this Act would, or could reasonably be expected to, do any of the following:

- (a) prejudice the effectiveness of procedures or methods for the conduct of tests, examinations or audits by an agency;
- (b) prejudice the attainment of the objects of particular tests, examinations or audits conducted or to be conducted by an agency;
- (c) have a substantial adverse effect on the management or assessment of personnel by the Commonwealth or by an agency;
- (d) have a substantial adverse effect on the proper and efficient conduct of the operations of an agency.

Note: Access must generally be given to a conditionally exempt document unless it would be contrary to the public interest (see section 11A).

For a document to be exempt under section 47E(d) I must be satisfied that there is a reasonable expectation that its disclosure will result in a substantial adverse effect on the operations of an agency and that there is no overriding public interest in favour of disclosure.

Documents identified within the scope of your request were documents originating from the Australian Customs and Border Protection (ACBP) service, these documents contain the operating information of their agency, therefore I undertook an informal consultation with ACBP.

ACBP provided advice that certain information would, or could reasonably be expected to, have a substantial adverse effect on the proper and efficient conduct of their operations. Information regarding intelligence is operationally sensitive and would not otherwise be available to the public.

Taking into consideration all relevant factors I am satisfied that the information identified in the schedule as exempt, in part, under section 47E(d) could reasonably be expected, if disclosed, to prejudice the effectiveness of the operations of the ACBP.

Information found to be exempt under a 'public interest conditional exemption' requires a decision maker to consider whether release of the information would then be contrary to the public interest.

When considering if the release of the exempt material would, on balance, be contrary to the public interest I have taken into account the following factors.

### Factors favouring access:

- to promote the objects of the FOI Act;
- inform debate on a matter of public importance; and
- there is a general public interest in making information held by the Government accessible to the public.

### Factors against disclosure:

- prejudice the proper and efficient conduct of current and future operations of the ACBP; and
- prejudice security and the effectiveness of Australia's border protection operations

Releasing intelligence information about the way ACBP operates in relation to the protection of Australia's borders would have a substantial adverse effect to their ability to maintain current operations. I have given this the greatest weight when considering the public interest test. I am satisfied that releasing this information would be contrary to the public interest.

# Section 47F Public interest conditional exemptions—personal privacy

extract:

- (1) A document is conditionally exempt if its disclosure under this Act would involve the unreasonable disclosure of personal information about any person (including a deceased person).
- (2) In determining whether the disclosure of the document would involve the unreasonable disclosure of personal information, an agency or Minister must have regard to the following matters:
  - (a) the extent to which the information is well known;
  - (b) whether the person to whom the information relates is known to be (or to have been) associated with the matters dealt with in the document;
  - (c) the availability of the information from publicly accessible sources;
  - (d) any other matters that the agency or Minister considers relevant.

Note: Access must generally be given to a conditionally exempt document unless it would be contrary to the public interest (see section 11A).

The documents that are exempt, in part, under section 47F(1) of the FOI Act contain third party personal information.

Having formed the view that the documents are of a kind to which section 47F(1) does apply, in part, I am required to consider whether disclosure of the information would be unreasonable.

I have taken the following information into consideration:

- The information is of a sensitive nature and provides information of a kind that may allow other individuals, who can ascertain the identities, access to additional personal details that has not otherwise been released.
- The information is not your personal information.
- Every person has the right to expect that their personal information will be securely maintained by the department.
- The information does not appear to be in the public forum.

On balance I believe it would be unreasonable to release the third party personal information identified within the schedule.

Having formed the view that the information within the documents is of a kind to which section 47F(1) does apply, I am required to consider whether disclosure of the documents would be contrary to the public interest.

When considering if the release of the exempt material would, on balance, be contrary to the public interest I have taken into account the following factors.

# Factors favouring access:

- to promote the objects of the FOI Act;
- inform debate on a matter of public importance; and
- there is a general public interest in making information held by the Government accessible to the public.

# Factors against disclosure:

- prejudice the protection of an individual's right to privacy
- it is a core Government concern to maintain the integrity of the information it holds and in the maintaining of an individual's privacy

The information contained within the identified documents is sensitive personal information and wholly relates to third parties. The department is obliged to take action to prevent the unreasonable disclosure of an individual's personal information and I have given this the greatest weight.

I am satisfied that releasing this information would be contrary to the public interest and it is therefore exempt from disclosure under section 47F of the FOI Act.
