Introduction

As part of a comprehensive planning and development process, the Department of Immigration and Citizenship (now Department of Immigration and Border Protection) requested a quantitative research study to measure the current level of awareness and understanding of onshore diaspora community members on the government's current migration and humanitarian policies (as a result of changes from the Expert Panel on Asylum Seekers report).

Australia's Humanitarian Program is an important part of our contribution to the international protection of refugees. It is designed to ensure that Australia can respond effectively to global humanitarian situations and that support services are available to meet the specific needs of these entrants. Australia's migration policy changed in August 2012. The changes mean that Australia has:

- Significantly increased the number of humanitarian (refugee) visas available;
- Added an extra 4,000 visas for people who want to be reunited with their family in Australia; and
- Started sending people to Nauru and Papua New Guinea for the processing of protection (asylum) claims.

The most politically challenging issue in migration policy is the issue of people arriving in Australia by boat without a valid visa. Any irregular maritime arrivals since 13 August 2012 can now be transferred from Australia to a regional processing country. Transfers can be made to countries such as Nauru or Papua New Guinea. Any refugee claim made will be assessed by a regional processing country. If the migrant is later found to be a refugee, they will have to wait to be resettled, as other refugees do around the world. Other changes have been made so that people who arrive by boat do not benefit over other refugees who have been waiting for years.

In February 2013, the department launched the *Don't be sorry* campaign to inform diaspora communities of the changes. Benchmarking market research was undertaken prior to the start of the campaign activities. Market research was conducted to evaluate the *"Don't Be Sorry"* campaign in June 2013.

On Friday 19 July 2013 the then Prime Minister, Kevin Rudd, announced new changes to the asylum seeker by boat policy. The policy announced that asylum seekers arriving by boat without a visa would be transferred to Papua New Guinea and that even if they were found to be genuine refugees they would be settled in Papua New Guinea.

When the new changes to the policy were made the Department of Immigration and Border Protection ran a campaign in in-language and English-speaking media.

The target audiences were based on the languages that materials are available in:

- Afghans (Dari)
- Pakistanis (Pashto)
- Iraqis (Arabic)
- Iranians (Farsi)
- Sri Lankans (Tamil and Sinhalese)
- Vietnamese
- There is a secondary target of the general English-speaking public.

The following is a report of the results of a survey following the conclusion of the campaign







Survey Method

The survey was administered through a computer assisted telephone interview (CATI) by skilled and experienced bi or multi-lingual interviewers, in the language of choice of the participants. Great care was taken to set the participants at ease to encourage them to be honest and forthright in their contribution, and to overcome their fear of the consequences of expressing views about the Government.

A total of 501 surveys were completed with respondents from seven priority cohort groups as identified by the Department of Immigration and Border Protection including a mix of Melbourne and Sydney respondents.

The margin of error associated with a sample of this size is less than +/-4.5%. It should be borne in mind, however, that this margin of error will increase for analysis on sub-segments of the sample (e.g. for analysis based on gender and age) due to smaller individual sample sizes.

Quotas were applied to the total sample determined as follows:

- Note: 23 Kurdish interviews were also conducted in Phase 1. Vietnamese interviews in Phase 1 did not include campaign awareness questions.
- In addition a control group sample of 42 English-speaking interviews was obtained in Phase 2-1 and 100 English-speaking interviews were obtained in Phase 2-2.

Results in this report are based on unweighted data. Where possible, comparisons are made to the results from the benchmark survey undertaken in February 2013, to the "Don't Be Sorry" campaign evaluation undertaken in June 2013 and the dipstick evaluation of the "No Visa" campaign undertaken in August 2013.

It should be noted that the methods between the benchmark survey and the evaluation surveys differed. The benchmark survey was a mix of telephone and face to face data collection. The surveys were conducted by experienced bi or multi-lingual moderators, in the language choice of participants.

There were also differences between the sample structures and size of each survey. For the bench-mark survey a total of 180 surveys were completed with 30 respondents from six priority cohort groups comprising of Melbourne and Sydney respondents. The evaluation of the "Don't Be Sorry" campaign a







total of 321 surveys were completed from six priority groups. In addition 70 benchmark surveys were conducted in Vietnamese.






Significance Testing

Significance tests for all cells were conducted on the unweighted database. The test used was a Z-test. This is a two-tailed test of the difference between proportions for large samples. It tests if two sample proportions have come from a population with a given proportion or from two different populations.

The formula used for calculation of Z from a table is:



Results that are significantly different from the average are marked with blue box \Box in this report.





The Survey

The survey consisted of 24 questions and was divided into six sections:

- 1. Travelling to Australia your community
- 2. Attitudes towards people smuggling
- 3. Current policy in Australia
- 4. Information access and sharing
- 5. Advertising Awareness
- 6. Responsibility for sharing information







Executive Summary

- The largest number of in-language respondents (38%) said that people from their community came to Australia by accessing relevant visa programs. Just less than one quarter said that people from their community came to Australia mainly by boats. Respondents from the Afghan and Pakistani communities were significantly more likely to say that people from their community arrived mainly by boats without a visa than other diaspora respondents. This is quite different from the response to the same question from the benchmark survey where 29% said that people came mainly by accessing the relevant visa programs and three in ten came mainly by boats.
- More than three quarters of in-language respondents said that they feel that people from their community should comply with the requirements, including 36% who agree that it is complicated. Again this is quite different from the response to the same question from the benchmark survey where 60% said that the visa process was complicated and it made it difficult to comply with the requirements.
- One third of respondents say that people have no other way of coming to Australia compared to 71% of respondents from the benchmark survey. Afghanis (81%) and Pakistanis (60%) were significantly more likely to agree to this statement than other diaspora respondents. 28% of respondents said that people coming to Australia by boats were not real refugees but economic refugees (three times as high as the benchmark survey).
- 40% of in-language respondents and 55% of English only respondents believe that people from other communities are doing the wrong thing by arriving by boat without a visa.
- Over one third of the in-language respondents say that they know very little or nothing about the asylum seeker by boat policy. More than two thirds of English only respondents say that they know at least a little about the asylum seeker by boat policy with 38% knowing a fair bit or a lot.
- More than one third of in-language respondents and over four in ten English-only respondents say that they are aware that the policy has recently changed.
- Agreement with statements that relate to the asylum seeker by boat policy is mostly higher amongst respondents to the current (October 2013) survey than amongst respondents to the benchmark or the June 2013 survey. In particular there are substantial increases in agreement with the following:
 - Expanded programs
 - Both Australia and the UNHCR are increasing staffing to improve processing times (58% compared to 27% in the benchmark survey and 46% in June 2013);
 - Processing times for refugees are likely to reduce (51% compared to 24% in the benchmark survey and 45% in June 2013);
 - There are more lawful options to choose when coming to Australia (67% compared to 38% in the benchmark survey and 52% in June 2013).
 - Others
 - There will be a reduction in deaths of people who are trying to come to Australia by boat (69% compared to 41% in the benchmark survey and 44% in June 2013;
 - The changes aim to reduce the dangers of boat travel especially during the recent Monsoon season (70% compared to 23% in the benchmark survey and 51% in June 2013); and





- People who arrive by boat and are found to not be in need of Australia's protection will be returned to their country of origin (63% compared to 27% in the bench mark survey and 40% in June 2013).
- Agreements with the statements pertaining specifically to the new policy changes were higher amongst English-only respondents than amongst the in-language respondents.
 - The majority of respondents (60%) of in-language respondents and 65% of English-only respondents) agreed that people who arrive by boat without a visa will be transferred to Papua New Guinea for processing;
 - 44% of in-language respondents and 50% of English-only respondents agreed that even if found to be a refugee when processed in Papua New Guinea, they will not be settled in Australia; and
 - 49% of in-language respondents and 73% of English-only respondents agreed that people who arrive by boat without a visa will not be settled here.
- The main sources of information about Australia's migration policies used were:
 - Internet (37%) and 28% considered it very reliable and 68% somewhat reliable;
 - In-language television (21%) and 40% considered it very reliable and 54% somewhat reliable; and
 - Family and friends (25%) and 21% considered them very reliable and 67% somewhat reliable;
- The main source of information about Australia's migration policies for the community overseas are:
 - Family and friends (48%) which are considered reliable overall; and the
 - Internet (36%).
- 55% of respondents say that they are aware of advertising about Australia's asylum seeking by boat. 57% of English-only respondents were aware of any advertising.
- The main feature of the advertisement that were recalled were:
 - Come by boat and you won't be able to settle in Australia (40%).
- When prompted, 56% of respondents recalled seeing or hearing the "You won't be settled" campaign. Sinhalese (71%) %) were more likely to recall the campaign once prompted.
- The main messages recalled were:
 - Come by boat and you won't be able to settle in Australia (43%);
 - Do not come by boat (27%);
 - Apply by legal ways instead of coming by boat (24%);
- Respondents who had seen or heard the advertisement saw it on:
 - Television; and
 - Newspapers.
- 9% of respondents who had seen or heard the advertisement visited the website as a result of seeing or hearing the advertisement.

- 25% of respondents say that they have spoken to family and friends back home about Australia's migration policy.
- Respondents who have spoken to people from their community overseas have mostly spoken by phone and told their family and friends that the policy has changed (33%) or to not come by boat, it is too risky (42%).
- Overall respondents did not think that they played a significant role in their community with 25% saying it was only minor and 21% saying they were unsure. Similarly respondents thought they did not play a significant role with community overseas.
- Respondents are most likely to say that the people smugglers must be stopped when asked what should be done.










Key Findings

Travelling to Australia – your community

1. How are people from your community coming to Australia?

- Of the 401 in-language respondents that completed the survey, a total of 34% said that people from their own community are coming to Australia by either accessing relevant visa programs or arriving by boat without visas. This is lower than results found in the benchmark survey or in the June 2013 survey.
- Just over a quarter of all respondents (fewer respondents than in the benchmark survey and similar to the June 2013 survey) believe that people from their community mostly arrive into Australia by boat without a visa (Iranian, (33%), Afghan (49%) and Pakistani (43%) were significantly more likely to say this.
- Nearly four in ten respondents believe that people from their community are accessing relevant visa programs to travel to Australia (a little higher than found in the benchmark survey). Respondents from Sri Lankan Sinhalese (83%) communities were significantly more likely to say this.










2. Which statement best describes how you feel about the visa process for people from your community coming to Australia?

- Just over one in five respondents agreed that the visa process is a complicated one therefore making it difficult for people to comply with the requirements when coming to Australia compared to 60% who agreed in the benchmark survey.
- More than one third of respondents acknowledged that it is complicated however still expected people to comply with the requirements compared to just under one third in the benchmark survey.
- More than four in ten respondents thought the process appropriate and that people should comply with the requirements compared to only 8% in the benchmark survey.
- Sri Lankan Sinhalese (64%) and Vietnamese (59%) were significantly more likely to agree that the visa process is appropriate and people should comply with the requirements.
- Vietnamese were significantly less likely (27%) to say that it is complicated but they should comply with the requirements.
- Iranian (32%) and Tamil (30%) respondents were significantly more likely to say that it is complicated which makes it difficult for people in their community to comply with the requirements.



3. Which statement best describes how you feel about people from your community coming to Australia by boat without visas?

- Only 36% (compared to 71% in the benchmark survey) of those surveyed indicated that their communities have no other way of coming to Australia but by boat without a visa. Afghanis (81%) and Pakistani (60%) were significantly more likely to agree with this statement.
- However 39% (compared to 21% in the benchmark survey) suggested that people who come by boat without visas are doing the wrong thing and should access the visa program correctly. Iraqis (73%) were significantly more likely to agree with this statement.
- 26% (compared to 8% in the benchmark survey) thought that those coming to Australia by boat were often not genuine refugees. Sri Lankan Sinhalese (43%) and Vietnamese (36%) were significantly more likely to agree with this statement.




4. Thinking about people from any country, not just your own, which statement best describes how you feel about them arriving in Australia by boat without a visa?

- Similar proportions of in-language respondents (34%) and English-only respondents (37%) agreed that people from any community have no other way of coming to Australia than by boat without a visa. Sri Lankan Tamil (48%) and Pakistani Pashto (53%) respondents were significantly more likely to agree with this statement.
- However 40% of in-language respondents and 55% of English-only respondents believe these people are doing the wrong thing by arriving in this way.
- 22% of all respondents suggest that people arriving by boat without a visa are not genuine refugees. Vietnamese (45%) respondents were significantly more likely to agree with this statement.



Current Policy in Australia

5. How much do you feel you know about the asylum seeker by boat policy in Australia? Would you say that you...?

- 30% of respondents claimed to know a fair bit or a lot about Australia's current asylum seeker by boat policy. There was no significant difference between English-only speaker respondents and in-language respondents.
- There were 33% who believe they know a little about it and 37% who know very little or nothing.
- Iraqi respondents were the most likely to claim no knowledge about the asylum seeker by boat policy in Australia.
- Tamil respondents were significantly more likely to say they know a fair bit about the policy.
- Afghan respondents were significantly more likely to say they know a lot about the policy.








- 6. Are you aware of recent changes to Australia's policy on asylum seekers coming by boat?
 - Awareness of the policy increased by 12% amongst the in-language respondents since the June 2013 survey and the number claiming to know nothing about it decreased by 17%.
 - Sri Lankan Sinhalese were significantly more likely to say that they were aware of recent changes in policy than other diaspora community respondents.






Expanded Programs

There is greater agreement with the statements about the policy than in previous waves of the survey, particularly amongst in-language respondents.










Offshore Processing



- The number of respondents who agree that the changes to Australia's migration policy aim to reduce the dangers of boat travel has more than doubled since the benchmark campaign.
- The number of respondents who agree that people who arrive by boat and are found to not be in need of Australia's protection will be returned to their country of origin has also increased since the benchmark survey. English speakers were significantly more likely to agree with this statement.










Information Access and Sharing

 - 3. Family and friends, as selected by more three in ten respondents












9a. How reliable would you say MAIN information [source] is?

- Information sources are considered reliable by most respondents.
- Whilst family and friends is the main source of information, one in five users of this information source consider it very reliable and only 11% consider it unreliable.
- In-language radio is considered very reliable by the most number of respondents who use this
 information source.
- The Internet is considered to be reliable by 96% of respondents who use the information source and Government websites are also considered reliable by 100% of users.



- 10. Where do you think people overseas get their information about Australia's asylum seeker by boat policies?
 - Whilst fewer respondents nominated friends and family as an information source compared to the benchmark survey this was the most commonly mentioned information source.
 - The Internet was the second most mentioned information source and in language respondents were significantly more likely than English speakers to think this.
 - English speakers were significantly more likely to say that people overseas get their information about Australia's asylum seeker by boat policies from Community organisations, religious or community leaders, social media, Twitter or People smugglers than respondents from the diaspora communities.
 - People smugglers were mentioned as an information source by 19% (35% of English speakers) compared to 32% in the benchmark survey.



- 11. How reliable would you say this information is?
 - Information sources are considered reliable by most respondents with one exception -
 - 69% of respondents say that people smugglers are unreliable as an information source (significantly higher than any other information source) and only 5% say they are very reliable (significantly lower than any other information source).
 - There is no significant difference between in language respondents and English only respondents






Awareness of Advertising

12. Have you seen any advertising recently about Australia's asylum seeker by boat policies? It doesn't matter whether the ads you saw were on TV, radio, in the newspapers, online, outdoors or anywhere else?

- More than half of all respondents said that they had seen advertising recently about Australia's asylum seeker by boat policies.
- Tamil respondents were significantly less likely to have seen the advertising with less than 20% of respondents claiming to have seen the advertising.
- Iranian, Sinhalese and English speaking respondents were significantly more likely to have seen the advertising.






Advertising Recall



- Tamil respondents were significantly less likely to have seen or heard the campaign.









- Over one quarter of respondents mentioned that the advertisement said "Do not come to Australia by boat".
- There were no significant differences between diaspora groups. English speakers were significantly more likely to say that the main message was to discourage or reduce asylum seekers.







- Tamil, Iranian and respondents who lived in Australia less than 5 years were significantly more likely to have spoken to friends and family back home.














Responsibility for Sharing Information








22. How would you describe your role in providing factual information about migration policies in Australia to your community overseas?











Demographics

24. How many years have you lived in Australia?





Summary and Recommendations

Success or failure of campaign?

With more than half the respondents recalling any advertising, awareness of Department of Immigration and Border Protection advertising is fairly high. There was no significant difference in recall of advertising between English-only respondents and the diaspora community respondents. Sinhalese were significantly more likely to recall the campaign than other respondents. Tamil respondents were again significantly less likely to have recalled a campaign.

Prompted awareness of the specific "You won't be settled" campaign was a higher than that found for the "Don't be sorry" campaign and higher than recall when the evaluation was conducted in July 2013, just one week after the commencement of the campaign.

We would suggested in July that the campaign amongst diaspora communities should continue based on the lower cut through of this specific campaign achieved amongst most of the communities. It may indeed have taken some time to reach the required level of awareness to ensure that the message has effectively been received by all diaspora communities. At the conclusion of the campaign we agree that most of the diaspora communities were adequately reached. However, in order to reach the Tamil community in particular, it would be worth investigating an alternative media strategy, since awareness remains low for all campaigns amongst this group.

• Messages

The predominant message that was received was that "people who arrive by boat won't be settled in Australia". Whilst in July this message had not yet filtered through to the in-language respondents the results indicate that most of the respondents from all diaspora groups and the English-only respondents who recalled the advertisement understood the main message.

Another test that the message had been delivered was in the agreement with the statements that particularly related to offshore processing and settling in Papua New Guinea. The majority of in-language respondents understood that people who arrive by boat without a visa will be transferred to Papua New Guinea for processing but there was greater confusion about whether or not refugees would be settled in Australia or Papua New Guinea amongst in-language respondents. The majority of English speakers understood this message. We would therefore suggest that this message needs to be continued to be communicated directly with the diaspora communities and that the media selection is targeted specifically at these communities.

An important part of the "Don't be sorry" campaign was to ensure that respondents understood that the policy had changed and to promote the positive aspects of the policy change. It should be noted that there was a change in agreement with many of the statements relating to the policy since the benchmark survey and at least some of these changes were acknowledged in the responses. We suggest that the positive components of the campaign are still cutting through, and should continue to be an important component of the advertising message.

• Media

The Internet and in-language television are both major sources of information for all diaspora groups but in-language respondents who had seen the campaign were most likely to have seen it on television. We suggest that the power of the Internet and sharing by social media be harnessed as much as possible. In addition to this we suggest that in-language television exposure be increased.

• Need for education about the asylum seeker by boat policy.

One third of respondents were aware of recent changes to the migration policy and overall, respondents did not feel that they knew a lot about the policy. However, it should be noted that there was increasing agreement with nearly all the statements that relate to the key messages in the policy. Given the focus of the election and subsequent decrease in general media mentions on the issue after September 7, 2013 it is possible that respondents were confused by the question and thought it related to "very" recent times. We would suggest that it is still important to ensure that diaspora communities are kept up to date with policy changes.

Since the benchmark, there has been an increasing number of respondents who say that people coming to Australia should comply with the requirements. We would recommend that continued reinforcement about the key points in the policy would ensure that all the correct messages were being delivered to friends and family overseas.

Likely response to communication

Whilst respondents did not think that they played a significant role in influencing either their community in Australia or overseas, one quarter of respondents had spoken to their friends and family back home about changes in Australia's asylum seeker by boat policies. Of those who had spoken to friends and family four in ten had told them not to come by boat, it is risky. One could argue that with or without a campaign this message may have been delivered. Many respondents had encouraged friends and family who lived overseas, to apply legally, to come to Australia. This is a key component of the campaign. The communities need to be continually encouraged, and provided with information to support this message.

In summary we would suggest that the campaign was effective amongst diaspora community groups and English-only respondents alike.




