## Scope of Request

I am requesting the details of any direct payments made on behalf of the Department of Immigration and Citizenship to the Government of the Republic of Nauru between January 1, 2012 and February 1, 2014. The information I require is the date of payment, amount of payment, reason for payment and to whom the payment was made.

I have been made aware by Immigration media that the information has already been found and passed to the minister's media aides, but have not been able to obtain it from them. The documents sought as part of this FOI request are only those provided by the department's media team.

### 118. Payments between the Australian and Nauru governments

#### Issue:

Personal Information subject to 11C(1)(a) asks about payments made between the Australian and Nauruan governments in relation to the operation of the detention centre.

#### **Talking points:**

- The transferee visa cost is \$3000 a quarter per transferee.
- Expenses in relation to water costs are not paid directly to the Nauruan Government, these are paid under contractual arrangements to suppliers.

#### Background (not to be released to the media):

The first memorandum of understanding (MOU) between the government of Australia and the Government of Nauru was signed by Ministers on 29 August 2012, with a subsequent MOU signed on 3 August 2013. In accordance with this MOU, the Government of Australia will fund agreed costs associated with the establishment and operations of the offshore processing centre on Nauru.

In September 2012, the Government of Nauru introduced the Australian Regional Processing Visa. Under Nauruan law, it is a requirement for all persons who have been transferred to the offshore processing centre in Nauru to hold an Australian regional processing visa.

Each visa is valid for a period of three months from time of grant – any transferees in Nauru after this period of time will require a further (three month) visa. The cost of each visa is AUD \$3000.

For the financial year to date (FY2013/14), the department has paid \$7 139 938 for costs associated with visas for transferees on Nauru.
