

I am happy with the proposed wording and concur that s. 22(1)(a)(ii) (or other senior legal personnel) are the preferred contact point with Shine, with support/info from DHSB and RPSB.

I spoke with both Kingsley and yesterday about how the matter of the transfer would be broached with on island. Our agreed preference would be for communication to occur in the normal manner (i.e. via IHMS) at the usual time (i.e. shortly before the transfer). While it is appropriate for Shine to convey the outcome to its client, there are a number of logistical/medical matters which will need the direct involvement of either ABF or SP staff on the ground. (e.g. practical matters such as how to prepare for/questions about the trip/procedure).

Given that plans are in place to effect the transfer well in advance of her procedure, certain medical matters can be addressed by IHMS VIDC/SIRH closer to the procedure date but, to minimise any potential complications (both medically and logistically) it is important that she be given the opportunity to ask questions/receive information about matters such as appropriate clothing, what items she can bring with her, what items she must bring with her (e.g. medications, health information) etc.

I suggest that, on island, a senior and well-briefed IHMS staff member be involved, and (subject to Kingsley's thoughts) a senior female ABF representative.

- 6. The Department is making arrangements to transfer **s.** 47F(1) to Australia shortly.

Purpose

To provide you with information about a sensitive case in Nauru involving a pregnant refugee women seeking termination of the pregnancy. The refugee claims she became pregnant after being sexually assaulted in the Nauru community.

Background

- 1. s. 47F(1) a Nauru-determined refugee from Somalia is pregnant and seeks to be brought to Australia for termination of the pregnancy s. 47F(1) claims she became pregnant after being sexually assaulted in the Nauruan community.
- 2. Since January 2013, s. 47E(d) transferees and s. 47E(d) refugees have been brought to Australia from Nauru s. 47E(d)
- 3. s. 47E(d) have been returned to Nauru and S. 47E(d) remain in Australia s. 47E(d) which is preventing their return to Nauru and S. 47E(d) a Bridging Visa E)

Key Issues

Current situation

- 6. International Health and Medical Services (IHMS), the contracted provider for transferee and settlement health in Nauru, advises that, "should S. 47F(1) not be transferred, there are risks of deteriorating mental health and psychological distress relating to an unwanted pregnancy under these circumstances."
- 7. Based on this medical advice, s. 33(a)(iii) s. 33(a)(iii)

the Department has agreed to bring

S. 47F(1) to Australia for the TOP.

- 8. Her procedure is scheduled for 16 October and arrangements are currently underway to transfer her from Nauru to Australia on the next available commercial flight.
- 9. s. 47F(1) will be informed of the arrangements as soon as transfer arrangements are confirmed and a letter will be sent to her legal representative confirming arrangements.
- 10. IHMS anticipates that S. 47F(1) would require a stay in Australia of one to two weeks following the procedure. S. 47F(1) does not have any dependants and the Department does not anticipate any refugees accompanying her to Australia.

Public commentary on this case

- 11. High profile anti-detention and anti-regional processing advocates S. 47F(1) have been lobbying for the provision of TOP services to publicly, including referencing the alleged sexual assault.
- 12. The Department has also received representation on this matter from Shine Lawyers and the s. 22(1)(a)(ii) These letters will be responded to in the coming days.
- 13. The Australian Human Right Council also sought to intervene in this matter and was advised by the Department that it did not have jurisdiction to do so.

Media talking points

- 14. The following media talking points have been prepared for use in relation to this case:
 - I am aware of some cases in Nauru in which refugee and transferee women have alleged sexual assault.
 - Investigation of alleged criminal activity in Nauru is a matter for the Government of Nauru.
 - The Australian Government funds the ongoing deployment of Australian Federal Police officers to support and mentor Nauru Police Force (NPF) officers in investigations, community policy and dealing with child abuse and sexual assault matters.
 - The Government of Nauru has also recently established a Gender Violence and Child Protection Unit within the Department of Home Affairs and a gender violence hotline will commence shortly.
 - The Government of Nauru operates a Community Liaison Officer (CLOs) programme
 under the watch of the NPF. CLOs provide a neighbourhood watch presence and are
 equipped to respond and report incidents, assist transferees and refugees with
 information and directions and contribute to the general safety and security
 throughout the community. The Government of Nauru intends to expand this
 programme following the announcement of full open centre arrangements.
 - The Department continues to work closely with the Government of Nauru to support the safety and security of all refugees living in the community.
