I refer to your email dated 26 February 2016 in which you request access to documents held by the Department of Immigration and Border Protection (the Department) under the *Freedom of Information Act 1982* (the FOI Act).

Scope of Request

You have requested access to the following documents held by the Department:

'The number and types of firearms legally imported into Australia in the three financial years 2012-2013, 2013-2014 and 2014-2015.'

NOTES:

For purposes of accurate comparison, it would be appreciated if these figures could be provided in the same format as was published in the Customs Annual Report up to, and including the 2011-2012 financial year.

Any easily accessible information which might assist in excluding firearms imported for law enforcement or military purposes from these totals would also allow accurate comparison with Customs counts of 'civilian' firearm imports published in each of the preceding 20 years.

This letter is to notify you of my decision on access to the documents subject to your request.

Decision on access

I am authorised under section 23 of the FOI Act to make decisions to release and to refuse access to exempt documents.

In accordance with section 17 of the FOI Act, the Department has used its computer system to produce one document that contains the requested information. The data produced in this document existed in the possession of the Department on 26 February 2016 when your FOI request was received.

Please note that in relation to your comment "Any easily accessible information which might assist in excluding firearms imported for law enforcement or military purposes from these totals would also allow accurate comparison with Customs counts of 'civilian' firearm imports published in each of the preceding 20 years", data previously provided in the Australian Customs and Border Protection Annual Report relate to commercial firearm importations, and will include firearms that are imported for supply to law enforcement and defence.

The decision in relation to the document in the possession of the Department which comes within the scope of your request is to release that document in full.

Your Review Rights

Internal Review

If you disagree with this decision, you have the right to apply for an internal review by the Department of this decision. Any request for internal review must be provided to the Department within 30 days of you being notified of the decision. Where possible please attach reasons why you believe a review of the decision is necessary.
