Freedom of Information – Decision on Access

I refer to your email dated 11 May 2017 in which you requested access to documents held by the Department of Immigration and Border Protection (the Department) under the *Freedom of Information Act 1982* (the FOI Act).

1 Scope of Request

You have requested access to the following documents held by the Department:

- 1. All documents relating to construction works undertaken at Weipa Customs House, Evans Landing between approximately 1966 and 1968, including but not limited to all building applications, plans, photographs and building consents;
- 2. Any asbestos registers produced in relation to Weipa Customs House, Evans Landing;
- 3. Any documents produced in relation to Weipa Customs House, Evans Lading that refer to Queensland Pastoral supplies from 1966 to 1968, and
- 4. Any documents relating to the presence and/or use of "asbestos", "A/C", "fibro", corrugated N/C", "Super Six", "Deep Six", Hardiflex", "Duraflex", "Hardiplank", "Wunderplant", "compressed A/C" or "Villaboard" at the Weipa Customs House from 1966 until 2017.'

This letter is to notify you of the Department's decision on access to the documents subject to your request.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions to in respect of requests to access documents or to amend or annotate Departmental records.

3 Relevant material

In reaching my decision, I have considered the following:

- the terms of your request;
- the documents relevant to your request;
- the FOI Act;
- Guidelines published by the Office of the Australian Information Commissioner under s 93A of the FOI Act, and
- advice from Departmental officers with responsibility for matters relating to the documents to which you sought access.

4 Documents in scope of request

Paragraphs 1 and 2 of your request relate to documents that are in the region of 50 years old. Generally speaking, the Department's Records Disposal Authority authorises the destruction of some documents after a period of 7 years after the last action on a matter.

Noting this, the Department has undertaken a search of its electronic records management system and identified a number of files that contain reference to Weipa Customs House in the title. These files date from 1993 only. It is further noted that a number of these files are marked as destroyed in accordance with the relevant Records Disposal Authority.

In order to ensure that any documents relevant to your request were identified, the FOI Section retrieved the files referred to above, and which are still retained by the Department. The contents of those files were reviewed and a number of documents were identified as being relevant to your request.

Through that process, a total of 28 documents were identified as falling within the scope of your request. These documents were in the possession of Department on 11 May 2017 when your FOI request was received.

A schedule of these documents is at **ATTACHMENT A** for your reference.

5 Decision on access

The decision in relation to the documents in the possession of the Department which come within the scope of your request is to release the 28 documents in part with information that is not relevant to your request deleted.

Section 22 of the FOI Act – irrelevant to request

Section 22 of the FOI Act provides that if giving access to a document would disclose information that would reasonably be regarded as irrelevant to the request, it is possible for the Department to prepare an edited copy of the document, modified by deletions, ensuring that the edited copy would not disclose any information that would reasonably be regarded as irrelevant to the request.

On 12 May 2017 the Department advised you that its policy is to exclude the personal details of officers not in the Senior Executive Service (SES), as well as the mobile and work telephone numbers of SES staff, contained in documents that fall within scope of an FOI request. We have also applied that policy to the names of individuals from the Department's contract service providers and officers from other Government Departments.

In addition to that, some information within the documents relates to property at locations other than Weipa, and I have taken the view that this information is not relevant to your request.

I have therefore decided that parts of documents would disclose information that could reasonably be regarded as irrelevant to your request, and have therefore prepared an edited copy of the documents, with the irrelevant material deleted pursuant to section 22(1)(a)(ii) of the FOI Act.

The remainder of the documents have been released to you as they are relevant to your request.

7 Your Review Rights

Internal Review
