Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate Departmental records.

Decision on access

I have consulted with the relevant business area in the Department, the Skilled Migration Programme Management Section.

In accordance with section 17 of the FOI Act, the Skilled Migration Programme Management Section has used its computer system to produce two documents that contains the requested information. The data produced in these documents was in possession of the Department on 27 June 2017 on receipt of your FOI request.

The Skilled Migration Programme Management Section has advised that the Department is unable to provide statistical information past 31 May 2017 as this data was not available at the time of your request. Furthermore, the visa streams for which you have requested data only came into effect from 1 July 2012, so no information would be available for earlier years.

As the scope of your request is for 'Statistics...up until the latest available year...', I am satisfied that the Department has fulfilled your request under the FOI Act.

My decision is to release the documents in full.

Review rights

Internal review
