Freedom of Information - Decision on Access

I refer to your email dated 13 July 2017 in which you requested access to documents held by the Department of Immigration and Border Protection (the Department) under the *Freedom of Information Act 1982* (the FOI Act).

Scope of Request

You have requested access to the following documents held by the Department:

documents relating to any instance where the Department paid for meals, accommodation or travel/transportation for the Department's Secretary, Secretary/Commissioner, ABF Commissioner and Six Deputy Secretaries in the 2016/17 financial year.'

This letter is to notify you of the Department's decision on access to the documents subject to your request.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions to in respect of requests to access documents or to amend or annotate Departmental records.

3 Relevant material

In reaching my decision, I have considered the following:

- · the terms of your request;
- the documents relevant to your request;
- the FOI Act;
- Guidelines published by the Office of the Australian Information Commissioner under s 93A of the FOI Act, and
- advice from Departmental officers with responsibility for matters relating to the documents to which you sought access.

4 Documents in scope of request

Although discrete documents providing the information you are seeking did not exist on the date of your FOI request (13 July 2017), the Department has been able to extract two reports from its systems which address your request. Under s.17 of the FOI Act, the Department is required to treat these documents as though they existed on the date of your FOI request.

The documents are:

- Document 1 (19 pages) a report of flights, accommodation and Qantas Business Travel fees charged to the respective Departmental Officers, specifically, Secretary, Commissioner, Deputy Secretaries and Deputy Commissioners, for the financial year 2016/17.
- Document 2 (4 pages) a report of travel allowance expenses paid to the Secretary, Commissioner, Deputy Secretaries and Deputy Commissioners, for the financial year 2016/17.

5 Decision on access

My decision is to release the two documents in full.
