# Freedom of Information (FOI) request - Access Decision

On 17 August 2017, the Department of Immigration and Border Protection (the Department) received a request for access to document under the Freedom of Information Act 1982 (the FOI Act).

#### 1 Scope of request

You have requested access to the following document:

'I have been granted a queue date "2 Jan 2013" for his visa application under remaining relative visa sub class 835. I've been waiting for 4 years without any updates or estimate of when my application will be released/awarded.

I would like to find out:

1. Number of carer visa applications being placed in queue from 13 June 2014 to date

2. Number of remaining relative and aged dependent visa applications being placed in queue from 08 March 2011 - 02 January 2013.'

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
