Freedom of Information (FOI) request - Access Decision

On 23 August 2017, the Department of Immigration and Border Protection (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following documents:

1. *"Documents regarding the cost of the Australian Border Force podcast*
2. *The total of the Australian Border Force communications budget*
3. *The Australian Border Force current communication strategy; and*
4. *The breakdown of where the Australian Border Force communications budget was spent".*

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.

3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the documents relevant to the request

- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- advice from Departmental officers with responsibility for matters relating to the documents to which you sought access and
- the Department's guidance material on the FOI Act.

4 Documents in scope of request

The Department has identified two documents as falling within the scope of your request. These documents were in the possession of the Department on 23 August 2017 when your request was received.

Attachment A is a schedule which describes the relevant documents and sets out my decision in relation to each of them.

The Department has undertaken reasonable searches in relation to the documents you have requested access to.

Searches

In summary, the Department has undertaken searches in relation to the following items as falling in the scope of your request.

For your information, communications activity for the ABF are encompassed in the overarching communications budget for the Department as a whole. Therefore, the Department does not hold any documents that fall within the scope of **Part 2** and **Part 4** of your request.

Having regard to your request and the types of documents that may fall within the scope of your request I am satisfied that the searches conducted were extremely thorough and all reasonable steps have been taken to locate any document relevant to your request.

5 Decision

Part 2 and Part 4

Section 24A of the FOI Act provided that the Department may refuse a request for access to a document if all reasonable steps have been taken to find the document and the Department is satisfied that the document does not exist.

Having considered the searches outlined above, I am satisfied that the Department has undertaken reasonable searches in relation to your request and that no documents were in the possession of the Department on 23 August 2017 when your FOI request was received. As such I am refusing access to the documents requested by you based on the application of section 24A of the FOI Act.

Part 1 and Part 3

The decision in relation to the documents in the possession of the Department which fall within the scope of your request is as follows:

- Release one document in full, and
- Release one document in part with deletions.

Detailed reasons for my decision are set out below.

5.1 Section 22 of the FOI Act – irrelevant to request

Section 22 of the FOI Act provides that if giving access to a document would disclose information that would reasonably be regarded as irrelevant to the request, it is possible for the Department to prepare an edited copy of the document, modified by deletions, ensuring that the edited copy would not disclose any information that would reasonably be regarded as irrelevant to the request.

On 24 August 2017, the Department advised you that its policy is to exclude the personal details of officers not in the Senior Executive Service (SES), as well as the mobile and work telephone numbers of SES staff, contained in documents that fall within scope of an FOI request.

I have therefore decided that parts of document marked 's22(1)(a)(ii)' would disclose information that could reasonably be regarded as irrelevant to your request, and have therefore prepared an edited copy of the document, with the irrelevant material deleted pursuant to section 22(1)(a)(ii) of the FOI Act.

The remainder of the document has been released to you as it is relevant to your request.

7 Your Review Rights

Internal Review

If you disagree with this decision, you have the right to apply for an internal review by the Department of this decision.
