# Freedom of Information (FOI) request - Access Decision

On 20 September 2017, the Department of Immigration and Border Protection (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

## 1 Scope of request

You have requested access to the following document:

- 1. The number of 189 visa application made for occupation 2211 Accountant after receiving EOI Invitation in the financial year 2016-2017
- 2. The number of 189 visa application made for occupation 2212 Auditors, Company Secretaries and Corporate Treasurers after receiving EOI Invitation in the financial year 2016-2017
- 3. The number of EOI invitations for occupation 2211 Accountant expire without a visa application in the financial year 2016-2017
- 4. The number of EOI invitations for occupation 2212 Auditors, Company Secretaries and Corporate Treasurers expire without a visa application in the financial year 2016-2017.

## 2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

## 3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- the Department's guidance material on the FOI Act

#### 4 Document in scope of request

The Department has identified one document as falling within the scope of your request. This document was in the possession of the Department on 20 September 2017 when your request was received.

#### 5 Decision

My decision is as follows:

- In relation to point 1 and 2 of your FOI request, I have decided to release one document in full.
- In relation to point 3 and 4 of your FOI request, I am refusing access to this part of your request on the basis that these documents do not exist.

Detailed reason for my decision is set out below.

#### 6 Reasons for Decision

Section 24A of the FOI Act provides that the Department may refuse a request for access to a document if all reasonable steps have been taken to find the document and the Department is satisfied that the document does not exist.

In relation to point 3 and 4 of your FOI request, I have consulted with the relevant business area and have been advised that the information being sought is not retained in a database maintained by the Department. Having considered this response, I am satisfied that the Department has undertaken reasonable searches in relation to your request and that no documents in relation to point 3 and 4 of your FOI request were in the possession of the Department on 20 September 2017 when your FOI request was received. As such I am refusing access to the documents requested by you based on the application of section 24A of the FOI Act.

## 8 Your Review Rights

#### Internal Review

Where possible please attach reasons why you believe a review of the decision is necessary. The internal review
