## Freedom of Information (FOI) request - Access Decision

On 21 June 2018, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

## 1 Scope of request

You have requested access to the following documents:

*"The Venezuelan Association of Australia kindly requires information about Venezuelan nationals who have lodged visas between January 2016 and 30 April 2018. Specifically, we require the following information:* 

1. Number of applications lodged between January 2016 and 30 May 2018 for Subclass 600 Visitor Visas including the Sponsored Family, Frequent Traveller and Tourist streams. Please include visas lodged offshore and/or onshore where the main applicant has applied using his/her Venezuelan passport. Additionally, the number of these applications that were approved or refused for each stream.

2. Number of applications for Subclass 600 Visitor Visas for the above streams that have been rejected or approved, from which the main applicant has an Australian relative living in Australia.

3. Number of applications for Student Visas, which have been lodged offshore and/or onshore where the main applicant has applied using his/her Venezuelan passport.

4. Number of these Subclass 500 visa applications that were approved or rejected, where the main applicant has opted for a Vocational Education and Training Sector course and/or Higher Education Sector course. Additionally, the number of these applications that were approved or refused for each stream.

5. Number of Subclass 200 Humanitarian Visas lodged onshore and/or offshore, including number of visa applications that were approved, rejected or that are still in progress.

We will appreciate if you can provide the information by these ranges of times: Jan 2016 – Jan 2017 Jan 2017 – Jan 2018 Jan 2018 – May 2018"

On 6 July 2018 you agreed to revise the scope of part 5 of your request to the following documents:

For Venezuelan citizens, all data for all of visas under the entire Humanitarian Program (on and offshore). This includes:

- Number of visa applications (on shore and offshore)
- Number of visas Approved
- Number of visas Rejected
- Number of visas in progress

We will appreciate if you can provide the information by these ranges of times: Jan 2016 - Jan 2017 Jan 2017 - Jan 2018 Jan 2018 - May 2018.

## 2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.

#### 3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the documents relevant to the request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines) and

In accordance with section 17 of the FOI Act, the Department has used its computer system to produce two documents that contain information that falls within the scope of your request. The data produced in the documents existed in the possession of the Department on 21 June 2018 when your FOI request was received.
