## Freedom of Information (FOI) request - Access Decision

On 26 June 2018, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

#### 1 Scope of request

On 26 June 2018, you requested access to the following documents:

Documents held by the Department in relation to the Australian Border Force College relating to the following:

- cases or allegations of bullying, harassment or discrimination/mental and emotional injury suffered by current and former staff, instructors and students;
- compensation and workplace injury claims by current and former staff, instructors and students;
- 3) the suicide of current and former staff, instructors and students;
- 4) staff turnover;
- the number and proportion of students who have left the college before completing their course;
- 6) Fairfax Media coverage of the ABF College on June 19;
- 7) current and former staff, instructors and students of the ABF College speaking to journalists..

On 5 July 2018, the Department sought to clarify the scope of each part of your request with you, noting that it had the potential to capture a large number of documents and did not initially reference a specific timeframe.

On 6 July 2018, you agreed to modify the scope of your request to the following:

- 1) A consolidated report of any cases or allegations of bullying, harassment or discrimination/mental and emotional injury suffered by current and former staff, instructors and students employed at or attending the ABF College, and across the ABF, since 1 July 2015 to the current date. In the event that a consolidated report is not available, a final investigation report of any such cases. Any identifying personal information can be regarded as outside the scope of my request.
- 2) A summary report of any compensation and workplace injury claims made by current and former staff, instructors and students employed at or attending the ABF College, and across the ABF, between July 1 2015 and the current date. In the event that a summary report is not available, a copy of the initial incident report. Any identifying and sensitive personal information, including medical information, can be regarded as outside the scope of my request.
- 3) A summary report of any suicide of current and former staff, instructors and students employed at or attending the ABF College, and across the ABF, from July 1 2015 to the current date. Any identifying and sensitive personal information, including medical information, can be regarded as outside the scope of my request.
- 4) Statistics relating to staff turnover at the ABF College from July 1 2015 to the current date
- 5) The number and proportion of students who have left the ABF College before completing their course from July 1 to the current date
- 6) Documents and correspondence created by ABF Senior Executive between June 19 and the current date regarding Fairfax Media coverage of the ABF College
- 7) Documents and correspondence created by senior executives from June 19 to the current date discussing any current and former staff, instructors and students of the ABF College speaking to journalists

On 9 August 2018, the Department again sought to further clarify part 1 of your request, noting that the modified scope had the potential to substantially and unreasonably diver the resources of the Department from its operations.

On 9 August 2018, you agreed to modify part 1 of the scope of your request as follows:

 A final investigation report of any cases where allegations of bullying, harassment, discrimination, mental/emotional injury have been substantiated in relation to staff, instructors and students whilst located at the ABF College for the period 1 July 2015 to 26 June 2018.

Part 2-7 of your request remain as agreed on 6 July 2018.

### 2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.

#### 3 Relevant material

In reaching my decision I referred to the following:

- · the terms of your request
- · the documents relevant to the request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- advice from Departmental officers with responsibility for matters relating to the documents to which you sought access

#### 4 Documents in scope of request

The Department has identified eight documents as falling within the scope of your request. These documents were in the possession of the Department on 26 June 2018 when your request was received.

**Attachment A** is a schedule which describes the relevant documents and sets out my decision in relation to each of them.

#### 5 Decision

The decision in relation to the documents in the possession of the Department which fall within the scope of your request is as follows:

- Release two documents in full
- Release relevant information in six documents

#### 6 Reasons for Decision

Detailed reasons for my decision are set out below.

#### 6.1 Section 22 of the FOI Act - irrelevant to request

Section 22 of the FOI Act provides that if giving access to a document would disclose information that would reasonably be regarded as irrelevant to the request, it is possible for the Department to prepare an edited copy of the document, modified by deletions, ensuring that the edited copy would not disclose any information that would reasonably be regarded as irrelevant to the request.

On 28 June 2018, the Department advised you that its policy is to exclude the personal details of officers not in the Senior Executive Service (SES), as well as the mobile and work telephone numbers of SES staff, contained in documents that fall within scope of an FOI request. As such, that information has been deleted as irrelevant to your request.

Document 1, relating to part 1 of your request, contains identifying personal information which you have expressly agreed may be regarded as outside the scope of your request. The document also contains information which does not consist of "allegations of bullying, harassment or discrimination/mental and emotional injury". As such, that information has been deleted as irrelevant to your request.

Document 3, relating to part 3 of your request, contains identifying and sensitive personal information, which you have expressly agreed may be regarded as outside the scope of your request. As such, that information has been deleted as irrelevant to your request.

Part 4 of your request is specifically for statistics relating to staff turnover at the ABF College. Information contained in this document which is not relevant to staff turnover at the ABF College has been deleted as irrelevant to your request.

Part 6 of your request is for documents regarding Fairfax Media coverage of the ABF College. Document 6.2 contains information on a number of unrelated matters. Those that do not relate to Fairfax Media coverage have been deleted as irrelevant to your request.

I have therefore decided that parts of documents marked 's22(1)(a)(ii)' would disclose information that could reasonably be regarded as irrelevant to your request. I have prepared an edited copy of the documents, with the irrelevant material deleted pursuant to section 22(1)(a)(ii) of the FOI Act.

The remainder of the documents have been released to you as they are relevant to your request.
