- The Minister thanked members of the Reference Group for their attendance.
- The Minister noted that David McNabb is an apology for this meeting.

#### 2. Update on items from previous meeting

# 2(a) Carrying hand-loaded ammunition aboard the Spirit of Tasmania

- The Minister noted that he had raised the issue of carrying hand-loaded ammunition aboard
  the Spirit of Tasmania with the Minister for Infrastructure and Transport,
  the Hon Darren Chester MP, who had consulted the Australian Maritime Safety Authority.
- The Minister agreed to send Catherine Fettell the contact details of an appropriately senior
  officer in the Australian Maritime Safety Authority to allow them to speak directly about the
  relevant technical issues.

- Members raised concerns about the updated Agreement, including that language used in the updated Agreement was different to language used in previous Agreements.
- The Minister stated that the updated Agreement had been relocated on the Attorney-General's Department's website so it was no longer under "crime and corruption".

#### 3(b) Genuine reasons – sports shooter

• The Minister stated that the regulations governing sports shooters with respect to membership of the Australian Clay Target Association have not changed.

#### 3(c) Black powder pistol shooting

• The Minister stated that the regulation of black powder pistol shooting has not changed.

#### 4. The process for checking serial numbers at the border

- The Minister stated that he received correspondence on this matter from Luca Scribani Rossi the previous week.
- Luca Scribani Rossi stated that he sees the current process as a burden.
- The Minister agreed to raise with the Minister for Immigration and Border Protection, the Hon Peter Dutton MP.
