

Summary of Victorian youth gang associates under cancellation consideration (as at 22 January 2018)

- Victoria Police have referred 76 individuals linked to Victorian youth gangs to the Department.
 - o 62 individuals were referred in April 2016
 - 19 were identified as foreign nationals
 - o Another one was referred in August 2016
 - o Another one was referred in February 2017
 - 20 individuals were referred in April 2017 (seven of which appeared on the first referrals)
 - Seven were identified as foreign nationals.
- The Department has identified another six individuals linked to Victorian youth gangs through media reporting and confirmed their links with Victoria Police.
- Of the 34 individuals linked to Victorian youth gangs:
 - o 10 have been cancelled
 - o 10 are under active cancellation consideration
 - 13 are not under active cancellation consideration (please see <u>Attachment A</u> for further information), and
 - 0 **\$47F**


Summary of Victorian youth gang associates under cancellation consideration (as at 15 February 2018)

- Victoria Police have referred 36 foreign nationals linked to Victorian youth gangs to the Department. These referrals were received between April 2016 and February 2018.
- The Department has identified another six foreign nationals linked to Victorian youth gangs through media reporting and confirmed their links with Victoria Police.
- Of the 42 foreign nationals linked to Victorian youth gangs:
 - o 9 have been cancelled
 - 9 are under active cancellation consideration
 - 24 are not under active cancellation consideration (15 of which are new referrals and are awaiting criminal history checks) (please see <u>Attachment A</u> for further information), and
