Summary of Victorian youth gang associates under cancellation consideration (as at 22 January 2018)

- Victoria Police have referred 76 individuals linked to Victorian youth gangs to the Department.
 - 62 individuals were referred in April 2016
 - 19 were identified as foreign nationals
 - Another one was referred in August 2016
 - Another one was referred in February 2017
 - 20 individuals were referred in April 2017 (seven of which appeared on the first referrals)
 - Seven were identified as foreign nationals.
- The Department has identified another six individuals linked to Victorian youth gangs through media reporting and confirmed their links with Victoria Police.
- Of the 34 individuals linked to Victorian youth gangs:
 - 10 have been cancelled
 - 10 are under active cancellation consideration
 - 13 are not under active cancellation consideration (please see [Attachment A](#) for further information), and
 - s47F .
