Freedom of Information (FOI) request - Access Decision

On 20 July 2018, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following documents:

1. *How many RSMS/187 visa nomination applications have been made over the past 5 program years (13/14, 14/15, 15/16, 16/17, 17/18) where the salary of the nominated occupation is less than \$53,900 for the following regions in Far North Queensland -*

- a. *Cairns - 4870;*
- b. *Tablelands (including Mareeba and Atherton) - 4680, 4605, 4880, 4883;*
- c. *Douglas (Port Douglas and Daintree) - 4354, 4814, 4877, 4873;*
- d. *Cassowary (Innisfail, Mission Beach region) - 4873, 4860, 4852; and*
- e. *Far North (Weipa and Cape York region) - 4874.*

2. *How many direct entry RSMS/187 visa applications have been made over the past 5 program years (13/14, 14/15, 15/16, 16/17, 17/18) for the following regions in Far North Queensland-*

- a. *Cairns - 4870;*
- b. *Tablelands (including Mareeba and Atherton) - 4680, 4605, 4880, 4883;*
- c. *Douglas (Port Douglas and Daintree) - 4354, 4814, 4877, 4873;*
- d. *Cassowary (Innisfail, Mission Beach region) - 4873, 4860, 4852; and e. Far North (Weipa and Cape York region) - 4874.*

3. *What occupations have been nominated for the TSMS/187 visa under the direct entry stream over the past 5 program years (13/14, 14/15, 15/16, 16/17, 17/18)? Include how many applications received for each occupation.*

4. *How many RSMS/187 visa applications are in the Department's pipeline?*

5. *How many ENS/186 visa applications are in the Department's pipeline?*

2 Authority to make decision
