## Freedom of Information (FOI) request - Access Decision

- f. postcode to be based on the address of the Standard Business Sponsor, not the agent or visa applicant
- g. postcodes with less than 5 results may be omitted
- h. non-standard postcodes may be omitted
- i. invalid applications may be omitted
- j. data to be presented in Excel spreadsheet format eg by individual year, with

postcode represented in columns (x-axis) and subclasses in rows (y-axis) A copy of the aforementioned s55F Agreement can be provided.
