Freedom of Information (FOI) request - Access Decision

On 11 May 2018, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

Documents produced in the last 5 years containing information showing each year:

- a) *the number of Vietnamese nationals granted student visas and*
- b) *the number of such visas cancelled each year and*
- c) *the reasons for such cancellation. I am particularly interested in information about such cancellations occurring because students being arrested and/or convicted of criminal offences.*

On 18 May 2018 you agreed to revise the scope of your request to the following documents:

Documents produced in the last 5 years containing information showing each year:

- a) *the number of Vietnamese nationals granted student visas; and*
- b) *data for the number of cancellations for any type of visa where the visa holder was of Vietnamese nationality and where the type of Visa is identified*
- c) *information as to*
 - i. *what cancellation powers under the Migration Act 1958 were used to cancel the visas at (b) of your request; and*
 - ii. *information including section 501 character cancellations with the details of the criminal offences.*

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- advice from Departmental officers with responsibility for matters relating to the document to which you sought access
- the Department's guidance material on the FOI Act

4 Document in scope of request

In accordance with section 17 of the FOI Act, the Department has used its computer system to produce one document that contains information that falls within the scope of your request. The data produced in the document existed in the possession of the Department on 11 May 2018 when your FOI request was received.
