Freedom of Information (FOI) request - Access Decision

On 14 December 2017, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

On 20 December 2017 the Home Affairs Portfolio, including the Department of Home Affairs, was formally established. The Department of Home Affairs includes the entirety of the Department of Immigration and Border Protection, the Australian Border Force and the Office of Transport Security from within the Department of Infrastructure and Regional Development. It also includes specific functions from the Attorney-General's Department, the Department of Social Services and the Department of the Prime Minister and Cabinet.

As such a decision has now been made on your request by the Department of Home Affairs (the Department).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

(a) A list of departmental officers with delegation to cancel visas under s109 of the Migration Act 1958 as at 24 November 2017, identified by position number.

On 12 February 2018 you provided further context to your request, as follows:

(b) The section of the Department my request relates to is the General Cancellations Network. If it assists, I can limit my request to the officers in the Visa Cancellation Unit – VIC. The request stems from a revelation that a number visa cancellations under s 109 of the Migration Act 1958 were made by an officer or officers without the requisite delegation.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the document relevant to the request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- advice from Departmental officers with responsibility for matters relating to the document to which you sought access
- the Department's guidance material on the FOI Act

4 Document in scope of request

The Department has identified one document as falling within the scope of your request. This document was in the possession of the Department on 14 December 2017 when your request was received.

Attachment A is a schedule which describes the relevant document and sets out my decision in relation to it.

5 Decision

The decision in relation to the document in the possession of the Department which fall within the scope of your request is as follows:

Release one document in full

6 Reasons for Decision

Detailed reasons for my decision are set out below.

In response to further addressing part (a) of your request, the Department can advise the following:

 The delegation of powers under the Migration Act are accorded on the basis of business area and level of position. Therefore, it is not possible to determine whether a particular person held the relevant delegation using position number alone.

In further addressing part (b) of your request, the Department is able to advise the following:

 Departmental systems indicate that on 24 November 2017 the General Cancellation Network made only one s109 cancellation decision. The Department of Home Affairs are able to confirm this decision was made lawfully and with the appropriate delegation according to the GIDAM 4 – Community Protection – Delegation and Authorisation 2017.

8 Your Review Rights
