



## Migration (Minister) (GIDAM 4 – Community Protection) Delegation and Authorisation 2017 (No.2)

I, Peter Dutton, Minister for Immigration and Border Protection:

- 1. acting under my powers in subsection 496(1) of the *Migration Act 1958* (the Act) and subregulation 1.16(1) of the *Migration Regulations 1994* (the Regulations), REVOKE the Governance Instrument of Delegation and Authorisation GIDAM 4 Community Protection, signed on 9 May 2017;
- 2. acting under my powers in subsection 496(1) of the Act and subregulation 1.16(1) of the *Migration Regulations 1994* (the Regulations), DELEGATE my powers under those provisions of the Act and the Regulations, excluding any instrument-making powers, specified in the relevant columns of Schedules 1 to 5 to this Instrument, to each person holding, or occupying, or performing the duties of, a position at the level indicated in Schedules 1 to 5 to this Instrument;
- 3. acting under the definition of "authorised officer" in subsection 5(1) of the Act, AUTHORISE each person holding, or occupying, or performing the duties of a position at the level indicated in Schedules 6 to 8 to this Instrument, to be an authorised officer for the purposes of those provisions of the Act and the Regulations that are specified in the relevant columns of Schedules 6 to 8 to this Instrument;
- 4. acting under the definition of "clearance officer" in section 165 of the Act AUTHORISE each person holding, or occupying, or performing the duties of a position at the level indicated in Schedules 9 to 10 to this Instrument, to be a clearance officer for the purposes of Division 5 of Part 2 of the Act; and
- 5. acting in accordance with subsection 496(1A) of the Act, DIRECT that the specified powers or functions may only be exercised by the specified officer only if the powers and functions are relevant to the officer's duties.

This Instrument, Migration (Minister) (GIDAM 4 – Community Protection) Delegation and Authorisation 2017 (No. 2), commences immediately after signature.
