## Whole of Government Talking Points: Skilled migration occupation list traffic light bulletin

- The Government is committed to ensuring that Australian workers are given the first priority for jobs, while allowing business to access the critical skills they need to grow if skilled Australian workers are not available.
- To support this, the skilled migration occupation lists that underpin Australia's skilled visa programs are reviewed regularly by the Department of Employment.
- The Department has released a Traffic Light Bulletin on possible changes to the skilled migration occupation lists, for the next update in January 2018.
- **This Traffic Light Bulletin is for consultation purposes only and does not represent a decision of the Government.**
  - Every stakeholder now has an opportunity, until 1 December, to put forward their feedback on the Traffic Light Bulletin.
- There were substantial changes to the lists in April and July this year. Therefore, the Government has prioritised continuity and stability.
- For this reason, no changes have been proposed for the medium and long-term strategic skills list.
- Following stakeholder feedback, the Department will provide its final advice to the Government for decision.
- The final decision on the lists will be made by the Minister for Immigration and Border Protection.

### *Next steps*

- Following this process, the next review is scheduled for the first half of 2018, for a July update to the lists.
- The Department will again undertake stakeholder consultation in support of the next review.

## **Portfolio specific talking points**

### Foreign Affairs and Trade

- The Department of Employment has worked with the Department of Foreign Affairs and Trade to ensure that international trade obligations are considered in providing advice on the composition of the skilled migration occupation lists.

### Health

- The Department of Employment has consulted the Department of Health in preparing the Traffic Light Bulletin. This recognises the responsibilities of the Health portfolio for medical workforce planning and the delivery of health services, including in regional Australia.

### Industry, Innovation and Science

- The Department of Employment has received advice from the Department of Industry, Innovation and Science to ensure that the Traffic Light Bulletin takes into account the skills needs required to support the Australian Government's National Innovation and Science Agenda.

### Agriculture and Water Resources

- A separate regional migration occupation list will be released for implementation in March 2018.
- Occupations that are not on the January 2018 skilled migration occupation lists remain eligible for consideration for the regional migration occupations list.
- The Department of Employment will release details regarding the regional migration occupations list after the current review process has concluded.
- Stakeholders with an interest in occupations where there are regional workforce needs are encouraged to engage with the Department at that time.
