INSTRUMENT OF DELEGATION AND AUTHORISATION 2015

I, PETER DUTTON, Minister for Immigration and Border Protection acting under my powers in subsection 496(1) of the *Migration Act 1958* (the Act) and subregulation 1.16(1) of the *Migration Regulations 1994* (the Regulations), and acting under the definition of "authorised officer" in subsection 5(1) of the Act:

1. REVOKE the Instrument of Delegation and Authorisation GIDAM 13 (International Division) signed on 2 March 2015; and
2. DELEGATE MY POWERS under the provisions of the Act and the Regulations specified in the relevant columns of the Attachment, to each person performing the duties of a position included in the positions and the classes of positions described in Column 1 (headed 'Classification and location or Level') in the Attachment; and
3. AUTHORISE each person holding, or occupying, or performing the duties of the positions and the classes of positions described in Column 1 (headed 'Classification and location or Level') in the Attachment, or performing the duties within a class of positions which include:
 - a. Minister Counsellor; or
 - b. Locally Engaged Employee (LEE); or
 - c. Locally Engaged Designate (LED); or
 - d. a position within the Department of Foreign Affairs and Trade (DFAT); or
 - e. a position within AusTrade,to be an authorised officer for the purposes of those provisions of the Act and the Regulations that are specified in the relevant columns of the Schedule to this Instrument.

This Instrument, GIDAM 13 (International Division), comes into effect on signature.
