# 6 Explanatory statement regarding the document released

The Department of Home Affairs has consulted with Department of Jobs and Small Business on the release of the report titled Experiences of Temporary Residents would like the applicant to note the information below:

"The Department of Jobs and Small Business notes that the Report was not published at the time it was drafted back in 2015 because the Department had some concerns about the methodology of the research (including the robustness of the survey, particularly regarding the salary levels of visa holders and comparisons to the national minimum wage). There were concerns around the methodology not supporting some of the conclusions in the Report about the experiences of certain migrant groups, notably regarding potential underpayment issues.) The Report also precedes Australian Government initiatives to address underpayment and exploitation of migrant workers, such as the Migrant Workers Taskforce. Disclosure of the Report may create the impression that the Report is presenting new information on the issues canvassed in the Report, whereas the information is in fact relatively old."
