Freedom of Information (FOI) request - Access Decision

On 26 June 2018, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

Statistics for 103 and 804 Visa Subclass applications and determination broken down by approved, refused and withdrawn by passport countries and by categories for last 5 years plus FY 2018.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

3 Relevant material

In reaching my decision I referred to the following:
