**Freedom of Information (FOI) request - Access Decision**

On 30 August 2018, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following documents:

*A document or documents which detail of what the Government of Nauru is stated to have agreed to in paragraph 8 of a letter [from the Department dated 22 August 2018 reference MC18-014794], where it is stated that the "Government of Nauru approved and implemented new, clearer procedures for service providers and staff at Nauru RPC" [in relation to delivery of letters to individual transferees].*

On 8 September 2018 you clarified that the scope of your request was to include:

*not just copies of the approvals for the latest mail handling procedures, but also the respective approvals for each version of the procedures.*

**2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.

### **3 Relevant material**

- the terms of your request
- the documents relevant to the request
- the FOI Act
