**Freedom of Information (FOI) request - Access Decision**

On 22 September 2018, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

- 9 Total number of case officers who process 309 and 100 visa globally
- 10 Total number of 309 and 100 application unfinalized until 01/09/2018 or until the latest date
- 11 Total number of case officers who process citizenship conferral application globally
- 12 Total number of citizenship conferral application unfinalized until 01/09/2018 or until the latest date
