Freedom of Information (FOI) request - Access Decision

On 26 September 2018, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

Financial figures for the last five years' budget and actual spend on flights and air transfers of detainees between immigration detention centres and deportations out of Australia. This is inclusive of the figures on flights both to and from Manus Island and Nauru. I am seeking the overall cost figures each financial year/reporting period and do not require the figures broken down. .

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the document relevant to the request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
