**Freedom of Information (FOI) request - Access Decision**

On 31 October 2018, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following document:

*For Financial Year 2017-2018:*

- 1) *Number of applications by source countries under visa streams (189, 190 and 489).*
- 2) *Number of determination (approved and refused) by countries of origin (top 20 countries) under the above visa streams.*
- 3) *Number of approvals by nominating state/territories under the visa streams.*
- 4) *Visa approvals -age of the applicants at the time of application, broken down into the five year increments by streams and by countries of origin.*
- 5) *Visa approvals -the profession nominated at time of application by streams and by countries of origin.*
- 6) *For Financial Year 2017-2018 the cut off points scores for the top 30 occupations under the above visa streams.*

## **2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
