An EOI may alter the recorded nominated occupation during their application process, however this has not been taken into account in the reported totals (only one of the nominated occupations is reported upon over the requested reporting period, this occupation was chosen arbitrarily)

An EOI may re-submit their application over a period, this has not been taken into account, an Intending Migrant submission is only counted once toward the reported totals

Each revision and re-submission may result in a different score being allocated to the EOI, only the highest score allocated over the reporting period has been used to count toward the reported totals, this score may not have been the final score the EOI was allocated in a scenario where the EOI was resubmitted over the reported period

The requested occupations are used as occupation categories/parents and are not available as valid occupations for selection, therefore all child occupations for the requested occupations have been used for the reported totals

The report is provided under an urgent time-frame, has not been subjected to a review process as would be involved in development release cycle, as such these figures should be treated an ad-hoc deliverable
