According to their contact information on the INTERPOL database, the INTERPOL Bangkok office is normally closed on Saturdays and Sundays. Royal Thai Police and the Thai Immigration Bureau may not be aware of the cancelled INTERPOL Red notice for this reason.

Reference is made to your below message with regard to the above mentioned individual.

In response to your query, kindly note that INTERPOL's current policy in handling refugee status provides that when information on an individual's refugee status is brought to the attention of the General Secretariat, and once this information is confirmed by the NCB of the country that granted the refugee status, the processing of Data should not be allowed through INTERPOL. This leads to the cancellation of the existing red notice and/or diffusion issued at the request of the country of origin against the individual.

In that regard, we would like to draw your attention to the IPCQ message sent earlier by IPSG (attached), informing all member countries that the red notice published at the request of NCB Bahrain against the individual ALARAIBI f/n Hakeem^{847F} is no longer value and that all information related to this individual has been deleted from INTERPOL's databases.

Mr Alaraibi was granted an Australian permanent protection (subclass 866) visa on 30/11/2017, and remains the holder of that visa.

2 Confirmation is also required that any information provided by you in relation to ALARAIBI can be shared with the INTERPOL General Secretariat Office of Legal Affairs to assist in their review of the validity of the INTERPOL Red Notice issued by Bahrain.

The answer to question 1 may be shared with INTERPOL General Secretariat Office of Legal Affairs to assist in their review of the validity of the INTERPOL Red Notice issued by Bahrain.

3 The Office of Legal Affairs has also requested in the event that ALARAIBI has been granted refugee status in Australia, if this information can be shared with other INTERPOL member countries.

We note that Bahrain is an Interpol member country. Australia has granted a protection visa to Mr Alaraibi s47F

As we have assessed Mr Alaraibi as engaging Australia's protection obligations, it would not be appropriate to confirm with Interpol member countries (including Bahrain) that Mr Alaraibi has been granted a permanent protection visa. It would, however, be permissible to advise Interpol member countries that "Mr Alaraibi is the holder of an Australian permanent residence visa". I hope this is of assistance.

Further to our discussion this morning, we would be grateful for some information on the protocols that are currently in place for Interpol/AFP to identify if the subject of an Interpol Red Notice is a refugee or asylum seeker.

Our Bureau is urgently seeking information with regards to ALARAIBI.

On 09 November 2018, INTERPOL Canberra received a notification from INTERPOL Headquarters indicating that Hakeem^{\$47F} ALARAIBI ^{\$47F} was subject of an INTERPOL Red Notice (control number A-11720/11-2018)published by INTERPOL Bahrain. The notification was part of a list of notices advising of new, updated and cancelled notices. INTERPOL Canberra

forwarded this notification to CMAL on 09 November 2018 as per our standard operating procedures.

On 27 November 2018, INTERPOL Canberra was advised by the AFP Operations Coordination Centre (AOCC) that ABF (^{\$22(1)(a)(ii)}) had advised ALARAIBI, who was subject of an INTERPOL Red Notice was departing Melbourne Airport on a flight to Bangkok. It appears no information was provided from ABF at that time that ALARAIBI was the holder of an Australian Protection Visa.

Our Bureau has been advised that ALARAIBI has been arrested in Thailand on the basis of the INTERPOL Red Notice, and we have received an urgent request from the INTERPOL General Secretariat Office of Legal Affairs, seeking to confirm if ALARAIBI is an asylum-seeker or has been granted or denied refugee status in Australia.

Under the INTERPOL Refugee Policy adopted by the General Assembly at its 86th session, in assessing the legal compliance of a request for a notice or diffusion, the General Secretariat should consider whether the individual is an asylum-seeker or refugee.

Please provide information regarding ALARAIBI's current visa status in Australia, including details when the visa was granted.

Confirmation is also required that any information provided by you in relation to ALARAIBI can be shared with the INTERPOL General Secretariat Office of Legal Affairs to assist in their review of the validity of the INTERPOL Red Notice issued by Bahrain. In the event that the INTERPOL Red Notice is deemed to be invalid on the basis of the subject's refugee status, the notice may be cancelled. This would remove the basis for the subject's current detention in Thailand, however, we are unable to advise if Thai authorities would release the subject back to Australia.

The Office of Legal Affairs has also requested in the event that ALARAIBI has been granted refugee status in Australia, if this information can be shared with other INTERPOL member countries.

My focus to date has been very much on attempting to secure Mr Alaraibi's return to Australia; but I agree that we need to look at what has occurred with this matter and how we can avoid such a situation in future.

I've asked similar questions of ABF colleagues (copied in) over the past week and I agree that it would be good to meet to try and very simply map out the process to determine what happened in this instance and why, so we can provide further advice as requested by Ministers.

If there is any scope to meet with the AFP Head of the Australian INTERPOL NCB this afternoon (considering the Ministerial interest) we think this would be beneficial considering the ongoing developments with this matter.

Thanks for taking my call.

My teams have been working back and forward with DHA on appropriate talking points relating to this matter. Unfortunately, there appears a disconnect in answering directly the questions relating to the role of the AFP. We consider this creates a gap in the narrative that has already been picked up on by Media outlets. We are conscious of the need to have coordinated media TPs with a consistent position from the Portfolio, however the suggested TPs do not answer the questions being put to the Portfolio.

This is the previous proposed talking points rejected by Home Affairs and their proposed alternative. AFP proposed:

- The INTERPOL National Central Bureau in Australia was not aware of the visa status of Mr AlAraibi at the time of his departure from Australia.
- When the INTERPOL National Central Bureau in Australia was advised that Mr AlAraibi held a refugee visa, that advice was provided to INTERPOL's Office for Legal Affairs) in accordance with INTERPOL rules, policies and procedures.
- Consequently, the Red Notice was cancelled within 24 hrs by INTERPOL's Office for Legal Affairs.
- Any determination of refugee status and processes surrounding visa grants is a matter for the Department of Home Affairs.

Home Affairs proposed:

- When applicants are granted a protection visa they are notified of the conditions and entitlements attached to it.
- Protection visa holders:
 - o are able to remain permanently in Australia and work without restriction
 - o are able to depart and re-enter Australia for five years from the date the Protection visa being granted.
 o must seek approval in writing from the Department of Home Affairs to enter the country from which they have been found to engage Australia's protection obligations.
 - o do not need approval to travel to any other country.
 - o to travel outside Australia, they must first contact an Australian Passport Office of the Department of Foreign Affairs and Trade to apply for a travel document, and not use the passport or travel document issued to them by their country of nationality.
- The AFP routinely cooperates and shares information with its international law enforcement counterparts.
- National law enforcement authorities can advise INTERPOL's Office for Legal Affairs (OLA) it believes a Red Notice should be cancelled. In this case it was cancelled within 24 hours.
- The Interpol Red Notice was not put in place by Australia; the existence of the Interpol Red Notice would have come to the attention of Thai authorities when the person attempted to enter Thailand.
- Any action taken in response to the Interpol Red Notice is a matter for Thai authorities.
- Any further questions on this matter are a matter for Thai authorities.

Talking Points

- Australia welcomes the Thai Government's decision to allow Mr Hakeem Alaraibi to return to Australia
 - o and commends Thailand's commitment to due process and human rights.
- The people of Australia have a great affection for Thailand and the Thai people
 - Australians deeply appreciate the Thai Government's decision, allowing Mr Alaraibi to return to his wife and his local community.
- Thailand is an important and longstanding regional partner for Australia, with which we cooperate closely on a wide range of issues and share strong people-to-people links
 - Thailand is our ninth largest trading partner
 - we look forward to continuing to work very closely with Thailand on a wide range of issues, including this year in support of its role as Chair of ASEAN.
- We also acknowledge the constructive dialogue we have had with Bahrain in helping to resolve this issue

- Australia and Bahrain share a friendly and longstanding relationship, underpinned by trade, people-to-people links and shared interests in defence and regional security
- this is a relationship which Australia will continue to build upon.
- We thank all those who have supported Mr Alaraibi during his detention, including his family and friends, the Football Federation of Australia, FIFA, and the IOC
 - we also thank Mr Alaraibi's legal team, which had worked extensively to support his legal case
 - and the Thai immigration and prison officials who facilitated regular access for the Australian Embassy while he was in detention.

If asked: Did Bahrain withdraw the extradition request?

• This was a matter between Thailand and Bahrain, and the Australian Government doesn't propose to comment on the details.

If asked: Has Australia received an extradition request from Bahrain for Alaraibi?

- Under Australia's Extradition Act 1988, the Attorney-General is responsible for considering any extradition requests, which are usually conveyed through diplomatic channels.
- As a matter of longstanding policy, the Australia Government does not comment on the details of its consideration of particular cases or our communications with foreign countries regarding extradition.

If asked: about the Australia-Bahrain bilateral extradition relationship:

• Australia does not have a bilateral extradition treaty with Bahrain.

If asked: Did the Australian Government do a deal with Thailand to secure his release?

• No. This was a decision by the Thai Government. Australia deeply appreciates the Thai Government's decision to allow Mr Alaraibi to return to Australia.

If asked: What is the Australian Government doing to ensure this situation is not repeated?

• *Relevant agencies are reviewing their procedures to try to ensure that this situation doesn't happen again.*

If asked: Have we damaged the bilateral relationship with Thailand by speaking out so forcefully on this matter?

• No, Australia and Thailand enjoy a long, deep and enduring partnership. Our engagement on this matter with all levels of the Thai Government is reflective of the deep and constructive relationship we have.

If asked: Have we damaged the bilateral relationship with Bahrain?

• No. Australia has a long-standing bilateral relationship with Bahrain, which is an important regional security partner.

If asked: Will Australia now grant Mr Alaraibi citizenship?

• I understand Mr Alaraibi was on the path to Australian citizenship, and any application will need to be considered in the usual way.

If asked: Why didn't the Australian Government just grant him citizenship?

• All applicants for citizenship must be physically in Australia at the time their case is decided.

If asked: Did Australia issue the INTERPOL Red Notice?

- No, the INTERPOL Red Notice was requested by Bahrain and issued on 8 November 2018.
- INTERPOL's 'Policy on the Processing of Data Relating to Refugees' requires close assessment of any country request for a Notice should they be known to be a refugee with a presumption to refuse the Notice request.
- As soon as INTERPOL was advised of Mr Alaraibi's status as a protected refugee by Australia, this procedure was followed and resulted in the cancellation of the Notice within 24 hours.
- Australia informed INTERPOL and the Thai Government of Mr Alaraibi's refugee status on 29 November, and the INTERPOL Red Notice was cancelled on 30 November.

If asked: Did DFAT provide advice to Mr Alaraibi regarding his safety in travelling to Thailand?

- The Department of Foreign Affairs and Trade (DFAT) did not provide assurances to Mr Alaraibi that it was safe for him to travel to Thailand.
- As a matter of standard practice, DFAT does not provide tailored or individualised travel advice.

If Asked: Did Mr Alaraibi travel on a refugee passport?

• Yes, Mr Alaraibi was travelling on a Titre de Voyage passport.
