Freedom of Information (FOI) request - Access Decision

On 05 February 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following documents:

- Number applications lodged by a main visa applicant for subclass 600 visitor visa all streams, where the main visa applicant had an offshore partner visa (subclass 309/100 or 300) in process by financial years ending 30 June 2016, 2017 and 2018.
- Number of granted visas by a main visa applicant for subclass 600 visitor visa all streams where the main visa applicant had an offshore partner visa (subclass 309/100 or 300) by financial years ending 30 June 2016, 2017 and 2018.
- Number of subclass 600 visitor visa holders all streams -where the main visa applicant had an offshore partner visa (subclass 309/100 or 300) by financial years ending 30 June 2016, 2017 and 2018 where the main applicant travelled to Australia and did not leave within the visa validity period;
- Number of subclass 600 visitor visa holders all streams -where the main visa applicant had an offshore partner visa (subclass 309/100 or 300) by financial years ending 30 June 2016, 2017 and 2018 where the main applicant travelled to Australia and applied for a different visa category onshore (ie not genuine visitors).

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- advice from Departmental officers with responsibility for matters relating to the document to which you sought access

4 Document in scope of request

In accordance with section 17 of the FOI Act, the Department has used its computer system to produce one document that contains information that falls within the scope of your request. The data produced in the document existed in the possession of the Department on 05 February 2019 when your FOI request was received.

5 Decision

The decision in relation to the document in the possession of the Department which fall within the scope of your request is as follows:
