## Freedom of Information (FOI) request - Access Decision

On 05 February 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

### 1 Scope of request

You have requested access to the following documents:

- The number of primary decision makers at the aps4 level in the department making decisions on 820/801 partners visas in 01/01/2013 and in 01/01/2019.
- The number of primary decision makers at the aps4 level in the department making decisions on student visas (all subclasses) visas in 01/01/2013 and in 01/01/2019.
- The number of primary decision makers at the aps4 level in the department making decisions on citizenship applications in 01/01/2013 and in 01/01/2018.
- The number of primary decision makers at the aps4 level in the department making decisions on sponsored family stream visas (all subclasses) visas in 01/01/2013 and in 01/01/2019

### 2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.

### 3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the documents relevant to the request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- advice from Departmental officers with responsibility for matters relating to the documents to which you sought access.

In accordance with section 17 of the FOI Act, the Department has used its computer system to produce one document that contains the information that falls within the scope of your request. The data produced in the documents existed in the possession of the Department on 05 February 2019 when your FOI request was received.

The internal review will be carried out by an officer other than the original decision maker and the Department must make a review decision within 30 days.
