### Freedom of Information (FOI) request - Access Decision

On 07 February 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

#### 1 Scope of request

You have requested access to the following documents:

- 1) How many tourist/visitor visas were issued in the financial years 2016-2017 and 2017-2018 and 2018-2019 (till December 2019) to the applicants who age between 15 to 40years from Australian High Commission, New Delhi?
- 2) How many of these tourist visa holders applied for the student visas (that is from subclass 600 to subclass 500) while onshore? and
- 3) How many applicants got approval/refusal for student visa applications?

#### 2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.
