**Freedom of Information (FOI) request - Access Decision**

On 15 February 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following documents:

*For Invitation round 11 July 2018 to present:*

- 1) *How many EOIs in the pool where invitation to apply has not been extended in your 189 EOI system for ALL (including pro rata and non pro rata occupations) at 65-85 points*
- 2) *How many EOIs in the pool where invitation to apply has not been extended are in your 189 EOI system for the ANZSCO grouping 2211 at 65- 85 points*
- 3) *How many EOIs in the pool where invitation to apply has not been extended are in your 189 EOI system for the ANZSCO grouping 2212 at 65 points - 85 points*
- 4) *How many EOIs in the pool where invitation to apply has not been extended are in your 189 EOI system for the ANZSCO grouping 2611 at 65 - 85 points*
- 5) *How many EOIs in the pool where invitation to apply has not been extended are in your 189 EOI system for the ANZSCO grouping 2613 at 65 - 85 points*
- 6) *How many EOIs in the pool where invitation to apply has not been extended are in your 189 EOI system for the ANZSCO grouping 2631 at 65 - 85 points*
- 7) *How many EOIs in the pool where invitation to apply has not been extended are in your 189 EOI system for the ANZSCO grouping 2334 at 65 - 85 points*
- 8) *How many EOIs in the pool where invitation to apply has not been extended are in your 189 EOI system for the ANZSCO grouping 2335 at 65 - 85 points and*
- 9) *How many EOIs in the pool where invitation to apply has not been extended are in your 189 EOI system for the ANZSCO grouping 2339 at 65 - 85 points*

On the 15th of March 2019 you confirmed with us that you accepted the Department reporting this data as at 11 February 2019.

## **2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

The data produced in the document existed in the possession of the Department on 15 February 2019 when your FOI request was received.
