**Freedom of Information (FOI) request - Access Decision**

On 12 March 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following documents:

- 3) *How many EOIs in the pool where invitation to apply have been issued in your 189 EOI system for the ANZSCO grouping 2212 on 11/Mar/2019*
- 4) *How many EOIs in the pool where invitation to apply have been issued in your 189 EOI system for the ANZSCO grouping 2611 on 11/Mar/2019*
- 5) *How many EOIs in the pool where invitation to apply have been issued in your 189 EOI system for the ANZSCO grouping 2613 on 11/Mar/2019*
- 6) *How many EOIs in the pool where invitation to apply have been issued in your 189 EOI system for the ANZSCO grouping 2631 on 11/Mar/2019*
- 7) *How many EOIs in the pool where invitation to apply have been issued in your 189 EOI system for the ANZSCO grouping 2334 on 11/Mar/2019*
- 8) *How many EOIs in the pool where invitation to apply have been issued in your 189 EOI system for the ANZSCO grouping 2335 on 11/Mar/2019*
- 9) *How many EOIs in the pool where invitation to apply have been issued in your 189 EOI system for the ANZSCO grouping 2339 on 11/Mar/2019*

The data produced in the document existed in the possession of the Department on 12 March 2019 when your FOI request was received.
