- 2. That OMARA reviews and confirms whether the prospective assessors meet the clean record criteria requirement; and
- 3. That OMARA confirms approval of any of these prospective assessors to be Approved Subcontractors as defined under the Deed of Variation.

### Criteria for assessors

Proposed assessors have been selected on the basis that they satisfied the following selection criteria:

- 1. At least ten years' experience as registered migration agent;
- Experience across a variety of areas of migration practice, with some knowledge of the challenges faced in sole practice and experience in supervising junior registered migration agents; and
- 3. Demonstrated contribution to the migration agent profession service on professional committees, pro bono work, authorships, submissions to government, mentoring experience etc.

The fourth selection criteria, which the College is not able confirm without the input from OMARA, is that the prospective assessors have clean record with OMARA.
