# Freedom of Information (FOI) request - Access Decision

On 15 April 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

# 1 Scope of request

You have requested access to the following documents:

Any information, records, paper documents, electronic records, or the contents of any records, paper documents or electronic records (including copies of such records and documents), held or accessible by the Department of Home Affairs ['the Department'] in relation to:

- a. Outlining, documenting or summarising submissions received in response to the consultations on the Humanitarian Program.
- b. Outlining, documenting or summarising the face to face stakeholder consultations on the Humanitarian Program.
- c. Appraising or assessing the submissions received in response to the consultations on the Humanitarian Program.
- d. Reporting on the Department's response to submissions received in response to to the consultations on the Humanitarian Program.

Please provide documents for each annual consultation on the Humanitarian Program between 2014 to 2019.

#### 2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.

#### 3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)

#### 4 Documents in scope of request

The Department has identified 32 documents as falling within the scope of your request. These documents were in the possession of the Department on 15 April 2019 when your request was received.

**Attachment A** is a schedule which describes the relevant documents and sets out my decision in relation to each of them.

#### 5 Decision

The decision in relation to the documents in the possession of the Department which fall within the scope of your request is as follows:

- Release 12 documents in full
- Release 15 documents in part with deletions
- Exempt five documents in full from disclosure

#### 6 Reasons for Decision

Detailed reasons for my decision are set out below.

Where the schedule of documents indicates an exemption claim has been applied to a document or part of document, my findings of fact and reasons for deciding that the exemption provision applies to that information are set out below.

#### 6.1 Section 22 of the FOI Act – irrelevant to request

Section 22 of the FOI Act provides that if giving access to a document would disclose information that would reasonably be regarded as irrelevant to the request, it is possible for the Department to prepare an edited copy of the document, modified by deletions, ensuring that the edited copy would not disclose any information that would reasonably be regarded as irrelevant to the request.

On 18 April 2019, the Department advised you that its policy is to exclude the personal details of officers not in the Senior Executive Service (SES), as well as the mobile and work telephone numbers of SES staff, contained in documents that fall within scope of an FOI request.

On 4 June 2019 you agreed to exclude from the scope of your request identifiers of third parties who provided submissions for the consultations on the Humanitarian Programme between 2014 to 2019.

I have therefore decided that parts of documents marked 's22(1)(a)(ii)' would disclose information that could reasonably be regarded as irrelevant to your request, and have therefore prepared an edited copy of the documents, with the irrelevant material deleted pursuant to section 22(1)(a)(ii) of the FOI Act.

The remainder of the documents have been considered for release to you as they are relevant to your request.

# 6.2 Section 33 of the FOI Act – Documents affecting National Security, Defence or International Relations

Section 33(a)(iii) of the FOI Act permits exemption of a document if disclosure of the document would, or could reasonably be expected to cause damage to the international relations of the Commonwealth.

The phrase 'international relations' has been interpreted as meaning the ability of the Australian Government to maintain good working relations with other governments and international organisations and to protect the flow of confidential information between them. The expectation of damage to international relations must be reasonable in all the circumstances, having regard to the nature of the information; the circumstances in which it was communicated; and the nature and extent of the relationship. There must be real and substantial grounds for the conclusion that are supported by evidence.

I consider that the release of the information marked 's33(a)(iii)' in the documents would, or could reasonably be expected to cause damage to the Australian Government's international relations.

I am of the view that the disclosure of document number 17, 26, 29 and 32 could reasonably be expected to inhibit future negotiations between the Australian Government and a foreign agency and governments.

As such I have decided that the information redacted and marked 's33(a)(iii)" is exempt from disclosure under section 33(a)(iii) of the FOI Act.

### 8 Your Review Rights

#### Internal Review

The internal review will be carried out by an officer other than the original decision maker and the Department must make a review decision within 30 days.
