**Freedom of Information (FOI) request - Access Decision**

On 17 April 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following document:

- 1) *Number of Australian citizenship by conferral applications on-hand as at 17 April 2019, by year of lodgement in 16-17, 17-18 and 18-19 financial year.*
- 2) *Number of Australian citizenship by conferral applications lodged, by month for 2018-19 financial year*

**2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
