Freedom of Information (FOI) request - Access Decision

On 8 May 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

As an import vehicle enthusiast and member of several groups specific to imported vehicles (specifically JZA70 Supras) our groups have been trying to ascertain how many JZA70 Supras were imported & complied for road use in Australia. Is it possible to identify numbers imported/complied by State?

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
