**Freedom of Information (FOI) request - Access Decision**

On 3 June 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following document:

*Statistics on refused TSS nominations and the SAF levy collected on those nominations from commencement of the levy on 12 August 2018 to 3 June 2019.*

**2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

**3 Relevant material**

In reaching my decision I referred to the following:

- the terms of your request
- the document relevant to the request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- advice from Departmental officers with responsibility for matters relating to the document to which you sought access

#### **4 Document in scope of request**

In accordance with section 17 of the FOI Act, the Department has used its computer system to produce one document that contains information that falls within the scope of your request. The data produced in the document existed in the possession of the Department on 3 June 2019 when your FOI request was received.

In relation to part 2 of your request, the Department is unable to produce a document from its computer systems that would capture the SAF levy collected on the refused TSS nominations from commencement of the levy on 12 August 2018 to 3 June 2019. That level of detail is not available from its computer systems.

Having regard to your request and the types of documents that may fall within the scope of part 2 of your request I am satisfied that all reasonable steps have been taken to locate any document relevant to that part of your request.

#### **5 Decision**

The decision in relation to the document in the possession of the Department which fall within the scope of your request is as follows:

- Release one document in full.

#### **7 Your Review Rights**

##### Internal Review

The internal review will be carried out by an officer other than the original decision maker and the Department must make a review decision within 30 days.
