Notifications under the Miscellaneous Measures Act

- There have been 89 notifications for medical transfer (s198E) received by the Department since 2 March 2019.
- 67 of the 89 notifications have been deemed valid:
 - 24 have transferred to Australia
 - seven have been refused
 - 12 have been approved with transfer pending
 - zero are currently with the Minister for consideration
 - two are currently with the Independent Health Advice Panel for review
 - 22 submissions are being drafted for the Minister’s consideration.
- One notification is being assessed for validity.
- Two notifications previously assessed as non-valid are being re-assessed.
- 19 notifications have been assessed as non-valid.

*On 18 June 2019, the Federal Court gave a decision on the interpretation of s198E(1) and s198E(7) of the *Migration Act 1958*, which meant that 'treating doctors' need not have personal engagement with a transitory person. This has increased the number of notifications to the Secretary under s198E(1), as a number of medical practitioners had provided opinions based on a review of medical records.
