# Freedom of Information (FOI) request - Access Decision

On 25 June 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

# 1 Scope of request

You have requested access to the following:

- 1) The number of EOI (70 points) in submitted status, which contains 5 points of partner skills from 01/07/2017 to 25/06/2019 for the occupation 2211, 2212, 2334, 2335, 2339, 2611, 2613, 2631 under 189 visa.
- 2) The number of EOI (75 points) in submitted status, which contains 5 points of partner skills from 01/07/2017 to 25/06/2019 for the occupation 2211, 2212, 2334, 2335, 2339, 2611, 2613, 2631 under 189 visa.
- 3) The number of EOI (80 points in submitted status), which contains 5 points of partner skills from 01/07/2017 to 25/06/2019 for the occupation 2211, 2212, 2334, 2335, 2339, 2611, 2613, 2631 under 189 visa.
- 4) The number of EOI (85 points) in submitted status, which contains 5 points of partner skills from 01/07/2017 to 25/06/2019 for the occupation 2211, 2212, 2334, 2335, 2339, 2611, 2613, 2631 under 189 visa.

The Department is unable to provide the information over a range of time, but is able to provide the information at a particular point in time i.e. 'as at' 01/07/2017 and 25/06/2019. On 10 July 2019 you accepted an amendment to your scope to provide the information 'as at' these two dates.
