Thanks for the efforts you have made to locate the 3 x missing ballistic vest panels, noting that you were not Registrar at the time of the likely loss.

Some comments on the attached minute:

The ballistic vest panels remain missing and have not been located. Previous manual PDE issue registers may contained 1. details of the missing vest panel(s). These registers are located at the national repository and have not been examined.

I suggest recalling the register to see if there is a record of who the vest was issued to prior to early 2017 suspect it went missing sometime before the batch of vests were returned to Canberra in March 201

Ultimately, we are going to have to report this to the Executive and the Operational Safety Committee; they will ask if all avenues have been exhausted.

It is likely that ballistic vest panel asset number 09076631 was returned to Canberra in November 2017 with ballistic vest panel 09076630 (ref. point9).

It is not likely that the vest was returned to Canberra. We used to scan all vests into our storage and have conducted multiple audits since that time. If it was in our container, it is more than likely that it would have been scanned during one of our audits, even if we missed scanning it on the original transfer receipt. As it is, the vest has been 'missing' in audit since 12/03/2015, last audited 1/12/2013. It is unlikely to think that it would have been missing all this time but show up in the group of vests being sent to us.

It is probably that ballistic vest 20322190/91 was returned to Canberra in March 2016, along with all other vests listed on 3. administration document, Ballistic Vests - 2016 (ref point 10).

As per the above point, it is not probable that these ballistic panels were returned to Canberra. Again, they would more than likely have been scanned into the container and/or been picked up in one of our audits since if they were here. They were last audited in Sydney 24/03/2016 (after the other vests were sent to us?), missing in audit ever since.

Without labouring the point (I know 5.22(1) has spoken about this) if the vests were signed out in and or transferred from Sydney to us in *** we would have had a point in time verification of their location.

Sorry you're left holding the ball with this one but your next steps need to be:

- Recall the pre-2017 B757 Firearms/PDE Issue and Receipt Register and try and find any record of issue to an officer on that
- Do you have a B258 Receipt and Issue Voucher that covers the period? If so, check to see if they may have been transferred anywhere.
- If no joy there, we will need to start official notification to the Exec (yours and mine) and NSW Police as per the Operational Safety Order (2015):

9. LOSS OF APPROVED FIREARMS, MUNITIONS AND OTHER APPROVED ITEMS OF PDE

(1) An officer must report the loss of any approved firearms, item of munitions and/or approved items of P	DE to his
or her supervisor and armoury registrar as soon as practicable.	

(2) Upon notification of a missing firearm, munitions and/or item(s) of PDE, the officer's supervisor and/or Manager must initiate an immediate investigation to ascertain the circumstances surrounding the loss of the items. All efforts must be undertaken to locate and recover the missing items. Aff

- is notified of a lost or stolen approved firearm or item of munitions and/or PDE; or

must ensure that the details of the missing firearm, item of munitions or approved item of PDE are recorded in and reported to the appropriate police service, following investigation into the circumstances of the discrepancy; and report the matter to the relevant Senior Executive and the DOTG as a matter of urgency.

The 2018 version (that hasn't been officially released yet but will likely hit the streets any day) has some additional direction as to notifying the SDO and OSC. DOTG is secretariat of the OSC and will need to be advised in that 🖳 capacity.

In the meantime, I can move the 3 x panels off your armoury profile so they don't keep showing against your audit list.

- Multiple conversations were had with other Sydney armoury registrars from Investigations and 7. Waterfront in relation to the location of previous manual armoury registers with nil result.

A documentary search was conducted in relation to previous transfer records between NSW and other operational areas that failed to identify a date and time the missing items might have been transferred, noting that the manual PDE issue register in the Sydney office only goes back to the start of 2017, again with nil result.
- A NSW administration document, Vest Allocation 2013, shows that ballistic vest panel asset 9. number 09076631 was one half of a vest, with the other half of the vest being 09076630. Vest 09076630 was last scanned in Canberra on 12:03:48pm on 15 November 2017.
- 10. A NSW administration document, Ballistic Vests - 2016, shows that ballistic vest 20322190 / 91 was listed as a small regular ballistic vest. No further details are recorded as to whom the vest may have been issued to. This document was prepared for vests that were being returned to Canberra on 18 March 2016, All other vests on the list were scanned in Canberra on, or shortly after this date.
- On 17 November 2017, NSU Sydney were consulted and asked to check if they may have 11. received ballistic vest 20322190 / 91 - with nil result.
- On 23 November 2017, conversations were had with Investigations Support Supervisor 5. 22(1) 12. records relating to the return of vests to Canberra are annexure to this minute (Ballistic Vests - 2016). Recollections by s. 22(1)(a)(ii) and Investigations support officers were that, due to time pressures, a complete and correct record of vests sent to Canberra was not compiled, with the promise that the vests would be appropriately receipted upon arrival in Canberra.

- It is probably that ballistic vest 20322190/91 was returned to Canberra in March 2016, along with all other vests listed on administration document, Ballistic Vests - 2016 (ref point 10).

- Seek approval for ballistic protection items 20322191 and 20322190 to be removed from Regional Investigations NSW Armoury audit profile in **221XaXm

Background

On 5 October 2017 an audit of the Regional Investigations NSW armoury Personal Defensive Equipment (PDE) assets was undertaken by Armoury Registrar and Regional Investigations NSW staff. This was following an extended period of operational activity in the area. As a result of that audit by the Armoury registrar, five (5) items of PDE were noted as unaccounted for at the time:

- i. Ballistic vest item asset number 09076631;
- ii. Ballistic vest item asset number 20322191:
- iii. Ballistic vest item asset number 20322190;
- iv. ADI Mk5 Handcuff ADI080534;
- v. MK 3 OC Spray AB0470;

Following further enquiries by the Armoury Registrar, ballistic protection item asset number 09076631, ADI Mk5 Handcuff ADI080534 and MK 3 OC Spray AB0470 were accounted for and are not the subject of further discussions.

Unaccounted for following these enquiries were two (2) ballistic protection items 20322191 and 20322190.

Investigation

Between 5 October 2017 and 24 October 2017, the Armoury Registrar and Regional Investigations NSW staff conducted the following enquiries to locate the two (2) ballistic protection items unaccounted for;

- Regional Investigations NSW staff were emailed advising of the potential loss of two ballistic
 protection items and a request for information regarding its current location was made to all staff.
 No further information was obtained from this enquiry;
- The Armoury Registrar and Regional Investigations NSW staff conducted physical searches of the NSW Investigations armoury, Regional Investigations NSW evidence room, ante room, all investigations motor vehicles and storage areas. No further information was obtained from this enquiry;
- c) The Armoury Registrar emailed the s. 47E(d) noting the exceptions in the audit of 5 October 2017:
- d) The Armoury Registrar emailed Enforcement Operations, Regional Command, and Mobile Deployment Staff advising of the potential loss of the ballistic protection items and a requested for information regarding its current location was made. No further information was obtained from this enquiry;

On 26 October 2017, the Armoury Registrar, Regional Investigations NSW Staff and Risk and Assurance Branch personnel conducted an audit of Regional Investigations NSW armoury. The two (2) ballistic protection items were noted as missing during the audit.

Subsequent enquiries

An examination was conducted of all equipment registers in Regional Investigations NSW support area. During further examination of records the following information was located;

On an administration document, created by Regional Investigations NSW Support and titled '<u>Ballistic Vests – 2016'</u>, it shows that ballistic item 20322190 / 91 was listed as a small regular ballistic vest. No further details are recorded as to whom the vest may have been issued to.

This document was prepared by Regional Investigations NSW Support for ballistic protection items that were being scheduled to be transferred from Regional Investigations NSW armoury to Canberra NOTDS on 18 March 2016.

On 17 November 2017, the Armoury Registrar contacted NSW National Surveillance Unit (NSU) requesting information concerning ballistic vests 20322190 and 91. No further information was obtained from this enquiry.

On 23 November 2017, the Armoury Registrar made enquiries with Regional Investigations NSW Support Supervisor s. 22(1)(a)(ii) is a former registrar for Regional Investigations NSV

was able to confirm a bulk transfer of ballistic protection items from Regional Investigations NSW to Canberra NOTDS was conducted on 18 March 2016.

further advised that Regional Investigations NSW support officers were, due to time constraints unable to finalise a complete record of ballistic protection items sent to Canberra. This record being the Ballistic Vests document discussed above. NOTDS staff advised Regional Investigations NSW support officers at the time the ballistic equipment would be receipted in the canberra.

Records relating to the transfer of vests to Canberra are Annexure to this minute (Ballistic Vests – 2016).

Issues

The two (2) ballistic vest items 20322191 and 20322190 which are assets of Regional Investigations NSW have not been located to date and remain unaccounted for.



 b. An all Investigations email was sent, requesting any officers to return said missing items of PDE if located by an officer no reply was received in relation to this email.

 On 26 October 2017, in company with 2018 and 3 April follow up audit of Sydney Investigations PDE assets was undertaken with the PDA. The above listed items of PDE were noted as still missing.

 Further follow up audits were conducted on the dates listed below:

 14 December 2017, 27 February 2018 and 30 April 2018, the missing vests were not located at 5.
- 14 December 2017, 27 February 2018 and 30 April 2018, the missing vests were not located at any of these subsequent audits

- Multiple conversations were had with other Sydney armoury registrars from Investigations and 7. Waterfront in relation to the location of previous manual armoury registers with nil result.
- A documentary search was conducted in relation to previous transfer records between NSW and 8. other operational areas that failed to identify a date and time the missing items might have been transferred, noting that the manual PDE issue register in the Sydney office only goes back to the start of 2017, again with nil result.
- 9. A NSW administration document, Vest Allocation 2013, shows that ballistic vest panel asset number 09076631 was one half of a vest, with the other half of the vest being 09076630. Vest 09076630 was last scanned in Canberra on 12:03:48pm on 15 November 2017.
- 10. A NSW administration document, Ballistic Vests - 2016, shows that ballistic vest 20322190 / 91 was listed as a small regular ballistic vest. No further details are recorded as to whom the vest may have been issued to. This document was prepared for vests that were being returned to Canberra on 18 March 2016. All other vests on the list were scanned in Canberra on, or shortly after this date.
- On 17 November 2017, NSU Sydney were consulted and asked to check if they may have 11. received ballistic vest 20322190 / 91 - with nil result.
- On 23 November 2017, conversations were had with Investigations Support Supervisor 5.22(1) 12. records relating to the return of vests to Canberra are annexure to this minute (Ballistic Vests - 2016). Recollections by 5. 22(1)(a)(ii) and Investigations support officers were that, due to time pressures, a complete and correct record of vests sent to Canberra was not compiled, with the promise that the vests would be appropriately receipted upon arrival in Canberra.



I can advise you that I accessed the armoury on 31 October 2018 as the CAAIO to issue vests from ACT Investigations equipment.

In pulling down the vest outters from the top of the Investigations cabinet (we do not keep plates in vests, they are locked up separately), a bag may have fallen onto ACT Op Command vests and been issued inadvertently. The only reason this may have occurred is that the vests were not issued via the DNA handset as the handset was not functioning correctly. No other PDE was accessed or removed from the armoury at that time, only vests for Investigators attending warrant activity in Western Australia. All vests have now been returned.

I am more than happy to access the armoury tomorrow, complete a stocktake, and locate the possible missing vest. Are you able to provide me with the size and/or plate numbers?

The DNA handset issues have now also been resolved and it is functioning correctly.



ABF Shotgun Ammunition – Discrepancy in Stock Levels

Timing

Purpose

To:

1. Provide you with information in relation to a discrepancy in Australian Border Force shotgun ammunition stock levels and stocktake procedures.

Background

- 2. Up until early 2017, the Australian Border Force (ABF) utilised pump action shotguns operationally in Northern Command, specifically for officer protection against dangerous wildlife and remote area stranding. Ammunition for the ABF issued shotguns was procured, stored and deployed nationally by the then Armoury Compliance and Equipment Section within the ABF College.
- 3. The operational use of shotgun ammunition was suspended indefinitely in May 2017, with the suspension applied to all training and range practices. Remaining stocks of shotgun ammunition, covering a number of ammunition types, were held in a storage container at the ABF training facility. 5.47E(d)
- 4. In 2017, the then Armoury Compliance and Equipment Section was restructured and the logistics function transferred to the National Marine Unit. The remaining elements moved out of the ABF College and into Operational Readiness Branch (ORB) in 2018, and management of the shotgun ammunition was transferred to the s. 47E(d)

 Team.

Issues

- The 2019 GFP stocktake of shotgun ammunition was conducted on 2 July 2019 by current inventory
 management officers in Operational Safety Capability Section. This stocktake highlighted a discrepancy
 in the quantity of shotgun ammunition compared to the previous recorded GFP stocktake conducted in
 June 2018.
- 7. The current total shotgun ammunition count is s.47E(d) rounds of 12GA shotgun ammunition. The previous quantity recorded in June 2018 was s.47E(d) rounds of 12GA shotgun ammunition, resulting in a shortfall of s.7E(d) rounds.
- When the discrepancy was discovered an audit of historical TRIM records, shipping information and section records was conducted. The audit failed to locate any supporting documentation or any stocktake records that would explain the discrepancy.
- 9. It is probable that the shortfall is due to an incorrect manual ammunition count during the 2018 GFP stocktake and has likely occurred due to the ammunition not being in operational use, the large amount of ammunition in odd quantities of eight (8) variations (making it difficult to count in the small container) and the limited resources available to manage the stock.
- 10. Interim control measures have now been put in place to accurately manage the current stock of shotgun ammunition and record monthly stocktakes in TRIM. The physical storage of the shotgun ammunition has also been re-organised. ORB will shortly undertake an ammunition recount and then mark and seal the holdings.
- 11. ORB notes that implementation of assetDNA will provide a control for prevention of similar inventory management issues, with all national ammunition stocks to be recorded electronically. This will give an accurate ABF-wide inventory of ammunition stocks.
- 12. Current ABF 12GA shotgun ammunition stocks are sufficient and no further shotgun ammunition is required to be procured in the near future.
