Freedom of Information (FOI) request - Access Decision

On 1 July 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You requested access to the following document:

Family Violence Provision (FVP) statistics:

- 1) *Total successful FVP grants by gender (male and female) for 2017-18 period*
- 2) *Total FVP claims by gender (male and female) for 2018-19 period*
- 3) *Total successful FVP grants by gender (male and female) for 2018-19 period*

Partner visa statistics:

- 4) *Total number of visa applications under the following subclasses for 2017-18: subclasses 820, 309 and 300 (*doesn't need to be by gender)*
- 5) *Total number of permanent partner visas (subclass 801 and 100) granted by gender for 2017-18 period*
- 6) *Total number of temporary partner visas (subclass 820 and 309) granted by gender for 2018-19 period*
- 7) *Total number of prospective marriage visas (subclass 300) granted by gender for 2018-19 period; and*
- 8) *Total number of permanent partner visas (subclass 801 and 100) granted by gender for 2018-19 period.*

On 26 July 2019 you agreed to revise the scope of the first part of your request to the following documents:

Total number of applications granted based on having met FVP claims provisions.

Total number of applications refused based on not having met FVP claims provisions.

Total number of applications not yet finalised, where FVP claims have been made.

Broken down by gender for Financial Years 2017-2019.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.
