Freedom of Information (FOI) request - Access Decision

On 8 July 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

I would like to apply under the Freedom of Information Act 1982 for details of all reported privacy breaches during the period 20/12/2016-30/12/2016.

On 8 July 2019 you clarified your request to refer to the following document:

*Number of privacy breaches
Dates of reported privacy breaches
for the period 20/12/2016-30/12/2016.*

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the document relevant to the request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- advice from departmental officers with responsibility for matters relating to the document to which you sought access.

4 Document in scope of request

I note that your request, as clarified on 8 July 2019, did not seek any information about privacy breaches apart from their number and dates.

I have interpreted your request for dates to refer to the dates that privacy breaches were reported (that is, the date that the reports were received), not the dates that they occurred.

The Department has identified one document as falling within the scope of your request. This document was in the possession of the Department on 8 July 2019 when your request was received.

5 Decision

The decision in relation to the document in the possession of the Department which falls within the scope of your request is as follows:

- Release one document in full (with irrelevant material excluded)

6 Reasons for Decision

Detailed reasons for my decision are set out below.

6.1 Section 22 of the FOI Act – irrelevant to request

Section 22 of the FOI Act provides that if giving access to a document would disclose information that would reasonably be regarded as irrelevant to the request, it is possible for the Department to prepare an edited copy of the document, modified by deletions, ensuring that the edited copy would not disclose any information that would reasonably be regarded as irrelevant to the request.

The remainder of the document has been released to you as it is relevant to your request.

8 Your Review Rights

Internal Review
