Freedom of Information (FOI) request - Access Decision

On 10 July 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

The number of New Zealand citizens who have had their Australian visas cancelled and have been deported under section 116 and section 501 of the Migration Act 1958 since 2014 (inclusive).

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
