**Freedom of Information (FOI) request - Access Decision**

On 13 August 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following documents:

1. *How many submitted EOIs of Subclass 189 Visa are in the pool before 13/08/2019 for each occupation for 70 points, 75 points, 80 points and 85 points respectively*
2. *In terms of 85 points Accountants (ANZSCO 2211) with de-facto partner or spouse, how many submitted EOIs of Subclass 189 Visa are in the pool before 13/08/2019?*

On 14 August 2019 you clarified with us that you are referring to 'submitted' status of applications as of 12/08/2019 in the Skillselect system.

**2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

### **3 Relevant material**

In reaching my decision I referred to the following:

- the terms of your request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)

In accordance with section 17 of the FOI Act, the Department has used its computer system to produce one document that contains information that falls within the scope of your request. The data produced in the document existed in the possession of the Department on 13 August 2019 when your initial FOI request was received.
