Freedom of Information (FOI) request - Access Decision

On 12 August 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following documents:

For applications made by and on behalf of the citizens of Afghanistan between 1/7/2018 - 30/6/2019:

- 1. Number of visitor visa applications made
- 2. Number of visitor visas granted
- 3. Number of student visa applications made
- 4. Number of student visa granted
- 5. Number of onshore protection visa applications made by citizens of Iran who arrived on visitor visas
- 6. Number of onshore protection visa applications made by citizens of Iran who arrived on student visas
